#### **Welcome and Introductions**

Linda Wyatt (Chair) called the meeting of the Community Integration Advisory Commission (CIAC) to order and asked all in attendance to introduce themselves. The motion was approved

to allow Teresa Champion and John Contreras to join the meeting via conference call as allowed under FOIA.

#### **No Public Comment**

Minutes from the April 12, 2013 CIAC meeting were approved.

## Office of Civil Rights Complaint

Catherine Harrison provided a brief overview of the recent complaint filed with the Office of Civil Rights (OCR) at the U.S. Department of Health and Human Services by the Quality Trust for Individuals with Disabilities and the National Alliance on Mental Illness of Virginia concerning the use of Virginia's auxiliary grant program in congregate only settings. David Hominik reviewed the OCR complaint process and facts and figures regarding the office.

## Joint Subcommittee to Consult on the Plan to Close State Training Centers

Catherine Harrison reviewed comments on the draft letter to the Governor regarding the Joint Subcommittee. In particular, the letter included the Commission's desire that funding for community-based services be retained for that purpose and not be diverted to keep open state training centers. Motions were made and the letter was approved as written to send to the Governor

#### **Other Items of Interest**

Staff provided a brief overview of current activities involving Money Follows the Person (MFP), Section Q, the recent report of the DOJ independent reviewer, and Commonwealth Coordinated Care. Commission members discussed ongoing issues surrounding MFP with a motion being made, seconded, and approved to send a letter to the Governor to address prior authorization of personal care under the EDCD waiver and the inability to use transition dollars to cover "first month's rent", a common one-time expense for apartment leases.

#### **Housing Priorities Discussion**

Staff reviewed the rough draft of and Commission member suggested changes to the housing priority guidelines created from the April 12, 2013 meeting discussion.

Barry Merchant from VHDA provided background on the current housing landscape and criteria VHDA currently employs.

Joan Manley suggested changes and made the following motion to the draft guidelines:

- Separate the third bullet into two separate bullets that read:
  - o Housing that is funded should include universal design and accessibility features.
  - Housing should build upon resources available in the community such as proximity to public transportation or other services that enhance community living options.

Ms. Manley's motion was duly seconded and approved by the Commission. A motion was made and seconded to approve the guidelines as amended by Ms. Manley and by others who submitted comments before the meeting. The amended guidelines were approved by the Commission.
