Virginia Advisory Committee for the Education of the Gifted February 19, 2016

Lesley Hunley called the meeting to order. Motion to approve agenda by Teresa Ellison. Seconded by Patty Griffin.

Department of Education Report

- Donna has been reviewing webpages and will be working with the VDOE webmaster to redesign the VDOE gifted and Governor's School pages. She asked coordinators to supply information about 'what's happening in gifted education'. She will try to update monthly some happenings in the state with a picture and short blurb; these will be archived too.
- Donna is working on improving data accessibility in SSWS so that coordinators can use
 the information to make informed decisions about their programs and services. Donna's
 goal is to have data to show student growth and trends in other areas, such as referral
 and identification.
- The Governor's budget included the new funding formula for Governor's School. An amendment was put forward to get rid of this formula and introduced a new formula but we will not know anything until February 21st.
- Applications for Summer Residential Governor's School applications due on February 25th.
- Hanover Summer Regional Governor's School for Career and Technical Advancement is sited in the Governor's budget to be fully funded in 2016.
- A suggestion was made for the January 2nd date to be changed for Summer Regional Governor's School for state adjudications. Donna explained that because of the tight schedule and the fact that the same judges attended each adjudication site, they had to start the first weekend after winter break. Next year the date should not be as close to winter break.
- Dornswalo Wilkins-McCorey and Cheryl McCullough raised the issue of difficulty in finding an accompanist, especially families who may not have the means to pay for one.
 Donna indicated she would communicate this to the adjudication program director.
- Another issue raised by the committee was giving students credit for working for their family instead of doing outside activities and training in order to give them credit and points on the application. Donna shared that we do not have to rank students based on

points and that we can flag students who we think will benefit from this opportunity, but who do not have similar experiences and trainings compared to other students.

ESSA

- O Gifted is mentioned in ESSA. Dr. Veronica Tate works at the VDOE with federal programs. Donna met with Dr. Tate about ESSA. Many people are trying to figure out what it actually provides to gifted education. Initially it was thought it would go into effect this year, but ESSA will become effective in 2017 school year.
- Dr. Tate is building a notebook about what this means for the gifted community.
 While everything is still being explored and defined, Dr. Tate indicated that there may be three different funding streams suitable for gifted education:
 - Student Support and Academic Enrichment grants: These are based on Title I funds; \$12 million may be available under this funding stream. LEA's will probably have to apply for funds.
 - Magnet School Grants: These may be 3-5 year grants that may require LEA application. The amount of available funds is uncertain.
 - High Ability Learning Grants (formerly Javits Grants): \$12 million; exact requirements have not been stated.
- Professional development money is also something we may be able to use.
 Donna will keep coordinators up to date as more information becomes available.

Subcommittee Reports and Develop Timeline for Follow Up

- Lesley Hunley asked George Fohl to share the results of the survey sent to coordinators about impactful practices for increasing identification of underrepresented populations. George shared that most coordinators in Virginia responded. George shared electronic documents for our work today.
- Donna suggested we review the information and create questions to ask the locals we
 visit.
- Lesley asked if we had a goal to visit a number of schools and whether we were looking at small, medium or large school districts. George shared that we want to look at the data and make decisions based on this information. Donna reminded the group to review the data that was shared at the last meeting.
- Donna reminded the group of the timeline for this group. Donna suggested dividing up the group between 4-5 people for visits and then do a case study on that location. Donna suggested we use the May/April meeting & the fall meeting for visits and use the rest of the year to do the write up for the presentations. Donna suggested that after teams visit each group should write-up their visit to be sure we have a record of the visit to help the new committee members who join VACEG this fall.
- The committee broke up into groups based on region to review the data to identify
 divisions to visit (see school chart included). Each group identified school systems to
 call for more information and potential visits (please see list at end of minutes). Donna
 will create the chart of schools for committee members to call and/or visit. George is
 creating a Google Document to organize this information for the committee. Donna will
 define a timeline for getting phones call completed and providing the required
 information to be assembled.

 After some discussion, it was decided that the report document would be written with heading of best practices in identification and then we would highlight certain divisions that were doing something outstanding with regard to that practice. We would start with phone calls and site visits may or may not be necessary. Once the phone calls are made the group would determine which site visits would be required. This is a different approach then the case-study approach that was discussed originally.

- Spring ID Testing of K-5 students (this is the first year serving first grade students)
