Mr. Melis informed the Board of several new laws affecting individuals and businesses regulated by DPOR which became effective July 1, 2012. including the de-regulation of hair braiding; expedited license application procedures for military spouses; credit for training obtained in the military; and unlawful procurement of a certificate, license or permit.

Mr. Anders will be representing the Board at the Annual Meeting of the National Association of Barber Boards of America, September 15 – 20, 2012 in Louisville, KY.

Other Board Business

There being no other business to be brought before the Board, the Chair adjourned the meeting at 12:21 p.m.
