Ms. Alderson, Chair, called the meeting to order at 8:45 a.m.

Call to Order

Ms. Alderson announced that Mr. Conrado O. Calpito had resigned Resignation of from the Board.

Ms. Alderson asked Mr. Howell and Mr. Piper to give a brief description of their background and experience. Ms. Alderson also introduced new staff Ms. Rashaun Minor, Administrative Assistant, and Ms. Earlyne Perkins, Legal Assistant.

Mr. Ferguson reminded the Board that in accordance with the Code of Virginia that the Tattoo and Body-piercing representative, Mr. Piper,

Harvey C. Johnson, Jr., Director of Johnson Beauty Academy, in Richmond, Virginia, expressed his concerns with maintaining students and enforcement of the regulations.

The motion passed unanimously. Ms. Alderson, as the presiding Board member at the IFF, was not present during the discussion or vote.

In the matter of File Number 2003-02783, Board v. Trung Thi Arai, the Board reviewed the record, which consisted of the investigative file, transcript and exhibits from the IFF, and the presiding Board member's Arai summary and recommendation.

Upon a motion by Mr. Howell and seconded by Ms. Howard-Seldon, the Board found clear and convincing evidence and voted to adopt violation recommendation that Trung Thi Arai was in violation of section 18 VAC 55-22-350(2) of the Board's 1999 Regulations. The members voting 'yes' were Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Quesenberry and Ms. Wilson-Clemmons. There were no negative votes. The motion passed unanimously. Ms. Alderson, as the presiding Board member at the IFF, was not present during the discussion or vote.

Upon a motion by Ms. Dudley and seconded by Ms. Howard-Seldon, the Board voted to amend the sanction recommendations and not impose a monetary penalty of \$2,500.00 but to revoke Trung Thi Arai cosmetology instructor's license. The members voting 'yes' were Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Quesenberry and Ms. Wilson-Clemmons. There were no negative votes. The motion passed unanimously. Ms. Alderson, as the presiding Board member at the IFF, was not present during the discussion or vote.

Ms. Sweet distributed copies of a memorandum to the Board addressing contract modifications and computer based testing sites as well as general statistics reports (attachment C). Ms. Sweet stated to the Board that as of January 2003 the theory portion of the examination converted to computer testing by Experior, at the request of the Board. Ms. Sweet stated that Experior moved all exam scheduling to St. Paul,

MN call center. Ms. Sweet stated that she encountered 4 months of problems with the St. Paul office and requested that all examination scheduling be returned and handled through the Richmond office. As of August 1, 2003 the Richmond office will be handling registration and scheduling of the exam.

In regard to the examination the Board discussed the critical areas of the exam.

Ms. Howard-Seldon handed out an e-mail received as well exam score sheets (attachments D).

Ms. Sweet advised the Board that it is charged with protecting the public and the Board made the decision at the time to include the critical areas in the exam as safety to the public.

Ms. Sweet also stated the exam fees set in the contract were low and will more than likely increase in 2005. Ms. Sweet stated the fees have remained the same for five years, however; Ms. Sweet is negotiating to keep the fees as low as possible.

Upon a motion by Mr. Quesenberry and seconded by Ms. Wilson-Clemmons the Board voted to modify the current contract and include 3 new programs wax technician, tattooing and body piercing, and hair braiding in the contract and extend Experior's contract to 2004. The members voting 'yes' were Ms. Alderson, Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Quesenberry and Ms. Wilson-Clemmons. There were no negative votes. The motion passes unanimously.

Mr. Quesenberry and Ms. Howard-Seldon reported to the Board on Education/Trainingtheir review of two Internet courses that were presented to the Board at Internet their last meeting. They reported that the theory portion might be taught online, but the practical instruction is a concern.

Upon a motion by Mr. Quesenberry and seconded by Ms. Howard-Seldon the Board voted to accept online training as a means of instruction for the theory portion of an approved program. members voting 'yes' were Ms. Alderson, Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Ouesenberry and Ms. Wilson-Clemmons. There were no negative votes. The vote passed unanimously.

Upon a motion made by Mr. Quesenberry and seconded by Ms. Dudley Wax Technician adopted the Proposed Wax Technician regulations and gave Board staff Regulations the authorization to revise as deemed necessary by the Office of the **Proposed** Attorney General or Executive Branch review. The members voting

Upon a motion made by Mr. Quesenberry and seconded by Ms. Dudley adopted the Emergency Wax Technician regulations and gave Board staff the authorization to revise as deemed necessary by the Office of the Attorney General or Executive Branch review. The members voting 'yes' were Ms. Alderson, Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Quesenberry, and Ms. Wilson-Clemmons. There were no negative votes. The motion passed by majority vote.

Mr. Ferguson informed the Board that the tattoo and body piercing regulations are at the Office of the Attorney General's awaiting a letter of assurance.

Tattoo and Board-Piercing Regulations

Mr. Ferguson informed the Board that the braiding Notice of Intended Regulatory Action has been filed for the promulgations of the hair braiding regulations.

Braiding NOIRA

Ms. Dugger distributed copies of the proposed hair braiders' license application with the methods of obtaining licensure (attachment H).

Upon a motion by Mr. Quesenberry and seconded by Ms. Alderson the Board voted to accept the criteria for the hair braiding license. The member voting 'yes' were Ms. Alderson, Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Ouesenberry and Ms. Wilson-Clemmons. There were no negative votes. The vote passed unanimously.

The Board took up representation for the National-Interstate Council of NIC Annual State Boards of Cosmetology (NIC) annual conference on August 22- Conference 25, 2003 in Sacramento, California.

Upon a motion by Mr. Ouesenberry and seconded by Ms. Howard-Seldon the Board voted to send Ms. Alderson as a representative of the Virginia Board to the 2003 NIC annual conference California. The members voting 'yes' were Ms. Alderson, Ms. Dudley, Ms. Howard-Seldon, Mr. Howell, Mr. Quesenberry and Ms. Wilson-Clemmons. There were no negative votes. The vote passed unanimously.

Mr. Howell expressed to the Board that as a new board member that the meeting was very interesting and enlightening. Mr. Howell also stated that the Board has many important issues before it and that the Board might meet more often.
