The Advisory Board recommended that continuing education hours for renewal be increased from 25 to 50 per biennium to conform to the requirements for renewal of professional certification. Additionally, the Advisory Board recommended that portions of the language regarding 18VAC85-170-150(B), "Exercise of the conscience clause," be revised to provide more safeguards for patients/clients. Ms. Creswick moved to approve the draft regulations as amended. The motion was seconded and passed.
