The vote was unanimous.

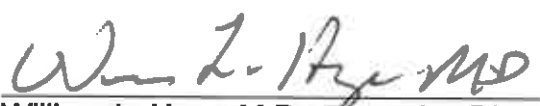

RECONVENE: Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and continued its discussion with Dr. Alexander regarding the allegations.

DECISION:

Upon a motion by Dr. Edwards, and duly seconded by Dr. Conklin, the Committee made certain findings of fact and conclusions of law and voted to reinstate Dr. Alexander's license with certain terms and conditions.

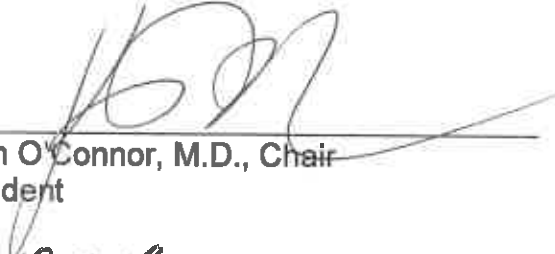
VOTE:

The Committee adjourned at 11:22 a.m.

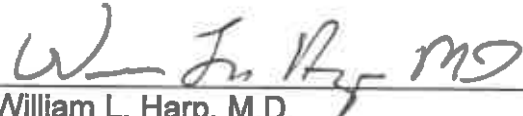
