I. Call to Order

The Commission on Local Government (CLG) Chair, Mr. R. Michael Amyx, called the meeting to order at 11:11 a.m.

II. <u>Executive Closed Session</u>

Mr. Michael Amyx motioned to end the executive closed session. This motion was properly seconded and unanimously approved by the Commission.

Pursuant to §2.2-3712 of the Code of Virginia, Ms. Rosemary Mahan filed a motion stating that there was no discussion within the executive closed session other than that of the citizen petition for annexation before the Commission on Local Government and that at no action was taken by the

III. Intermission

Ms. Linderman filed a motion to take a five minute break. This motion was properly seconded and unanimously approved by the Commission.

IV. Approval of Previous Meeting Minutes

Mr. Amyx motioned for the approval of meeting minutes from the March 14th meeting. This motion was properly seconded and unanimously approved by the Commission.

V. Public Comments

Mr. Amyx opened the floor for public comment. No public commenters presented themselves.

VI. <u>Administration</u>

Mr. Conmy introduced Cody Anderson, the new Legislative and Board Affairs Coordinator at the Virginia Department of Housing and Community Development. Mr. Conmy also updated the Commission on the imminent birth of the daughter of the Commission on Local Government's Senior Policy Analyst, Kristen Dahlman.

Mr. Conmy introduced to the Commission the newly appointed Commissioner Dr. Stephanie Davis, who was absent for this meeting, but will be attending the July 11th Commission meeting.

Mr. Conmy reported that there were no future cases that he was aware of that would be coming before the Commission. Mr. Conmy then provided a news roundup of local government issues happening all over the Commonwealth.

VII. Fiscal Stress Report

Mr. Akbor relayed to the Commission that the Fiscal Stress Report is coming along, but it is too early in the process to present results.

VIII. Reconvened Session

Mr. Conmy noted to the Commission that 23 bills were returned to the Governor during the reconvened session. He provided a desription of the bills and shared additional context on the topics.
