Proposed developments for the Park are presented in priority order. Completion of all of the projects in this list will represent total build-out (completion of the master plan), and covers a 20-year timeframe. The phasing costs are based on 2016 estimates. Estimates are based on 2016 cost figures.

PHASE I

Demo old bathhouse at group camp

Replace the park office and enlarge parking area

Construct 4 Yurts

Renovate beach bathhouse, concession facility and beachfront.

Add spray ground at beach area.

Construct a visitor center and upgrade amphitheater with comfort station

Renovate (25) cabins

Renovate campground

Renovate boat ramp, add parking.

Dredge Fairy Stone Lake

Renovate and expand internal trails and explore connections to external trails.

Resurface roads and parking lots throughout the park.
