OEMS has put together a paper that is found on the OEMS website, which will give you guidance if you are interested in that activity. Model Interstate Compact for EMS Personnel Licensure - The Department of Homeland Security gave the National Association of State EMS Officials (NASEMSO) a grant to create a document that recognizes EMS personnel working across state lines. The project is now complete. Mr. Brown along with our legal counsel, Amanda Lavin, from the Office of the Attorney General (OAG) will be traveling to Chicago for a one day meeting in June to review the finished product and discuss any possible legal issues. Each state EMS director, along with their legal counsel, has been asked to attend this meeting, and the travel costs are being funded through the NASEMSO grant. He said that the preliminary findings from the questionnaire were shared at the State Virginia Heart Attack Coalition meeting in Fredericksburg on May 2. Mr. Winston thanked Carol Pugh for gathering all the data and Paul Sharpe for his willingness to let her gather this data even though the unit was short staffed. Mr. Winston said that they had an excellent response rate, close to 80 percent. He said he was not aware of any major deficiencies identified. VPHIB v3 -Mr. Sharpe said he will begin sending out information on VPHIBv3 over the next couple of weeks. OEMS have received their version 3 product and have started familiarizing themselves with the product. Mr. Sharpe has put together a project plan and has mapped things out in good detail. 	 ICD-10 - Mr. Sharpe said he had some concerns after learning that they were moving the implementation date for ICD-10 out a year. He said he did some polling of State Data Managers and NEMSIS but has not heard of any issues. KKK-A-1822F Ambulance Standards — Mr. Berg talked about KKK-A-1822F Ambulance Standards Change Notice #6 and the implications that this change will have on future ambulances purchases. The standards were due to expire September 2014 but the end date was pushed back to September 30, 2015. Mr. Berg explained that the K specs Change Notice #6 was created to address some safety issues that both the National Institute of Standards and Technology (NIST) and the National Institute of Occupational Safety and Health (NIOSH) have been working on fixing for the past 10 years. Change Notice #6 fixes these issues; however, Mr. Berg pointed out that there will be a significant cost for new ambulance purchases. The General Services Administration (GSA) had a public comment period regarding this change notice. The Public Comment period ends May 21. Mr. Berg submitted a public comment on behalf of the Office of EMS and the EMS community asking that they delay implementation of the change for at least one year. NASEMSO also passed a resolution instructing the Executive Director to send a letter from NASEMSO requesting a delay in the implementation of Change Notice # 6.

Mr. Critzer said he will be attending the Fire and EMS Memorial Service. Chief Hoback reported that the Rules and Regulations committee met on Thursday. Chief Hoback reported that the FBI Fingerprinting is scheduled to go in effect on July 1. All agencies who hire new EMS providers must have the checks done and completed and in their personnel file. He said that the fingerprint cards have been distributed to all of the regional EMS councils. Chief Hoback asked Mike Berg to report on Regulatory activity. Mr. Berg reported that the Practitioner's Signature Regulatory Packet is still in the Secretary of Health and Human Services Office for their review and activity. Mr. Berg reported that another item coming forward as a regulatory packet has to do with the exclusionary criteria in Section 910 of the EMS regulations (12VAC5-31), but right now it currently talks about who can and cannot be certified. They left out the word "affiliated" when they put the last set of regulations together. Mr. Berg said he has already gotten approval from the Attorney General's Office that this can go through as a fast track packet. The paperwork is completed and needs to be submitted to VDH Administration for their review and approval. 	
Legislative and Planning Committee – Chris Eudailey	 Mr. Eudailey reported that the committee met earlier in the day. HB581 and SB355 - The committee is working on the comprehensive language clean up bills. They have met twice in March and April regarding this work, and they have another meeting scheduled on May 30 at OEMS at 10AM. Mr. Eudailey said that once the document is in the final revised draft form it will be put out for public comment. It is scheduled to come back to the State EMS Advisory Board in November for their final review and should be reintroduced in December as part of the Legislative package for 2015. Helicopter EMS Program (formerly known as WeatherSafe) – the quarterly data for weather turndowns can be found in the Quarterly Report. Mr. Perkins discussed some of the data and results. The committee drafted a letter to those centers with multiple events to remind them of the procedures that should be followed when calling for subsequent transport after having the initial request denied due to weather. The committee also drafted a letter to all Medevac communication centers as a reminder to have them ask people requesting service if there was a previous turndown due to weather. Landing Zones – The committee has images of landing zones for each hospital in the Commonwealth and has listed the images in the landing zone directory. New Rules Governing Air Medical Services - FAA put out an alert to announce new rules governing air medical services. The new rules were scheduled to go into effect on April 22; however, on April 21, the FAA put out another alert announcing that the implementation of those rules are delayed until 2015. Based on this information, the Medevac Committee will delay revising their state air medical regulations until they get additional information from the FAA. East Coast Helicopter Operations (ECHO) - Jon Kaminski of the Fairfax County Aviation Unit made a presentation at the meeting on behalf of East Coast Helicopter Operations (ECHO). ECHO is a collaborative effort involving providers from all over the east coast that represents military, law enforcement as well as air medical personnel.
