Call to order:	The meeting was called to order at 10:02 a.m. by the Chair, Anita Perry.	
Introductions:	Everyone around the room introduced themselves.	
Review & Approval of the February 6, 2014 minutes:	Anita asked if anyone had any input on the meeting minutes. No input was given. The minutes could not be approved because there was no quorum. The minutes were tabled until the August meeting. No official business can be voted on at today's meeting.	The February 6, 2014 minutes were tabled until the next meeting in August.

OEMS Report – Tim Perkins/OEMS Staff:	<p>Tim congratulated Anita on her recent marriage to Jim Perry.</p> <p>The committee chair had requested to change the committee composition but the original request was not accepted. Another proposed change was submitted and the Executive Committee is meeting today and will hopefully approve it today. Anita said that the first requested change would have enlarged the committee membership, because there was so much interest. However, the second request was a bit smaller. Once the decision has been made, an email will be sent out before the next meeting.</p> <p>Tim congratulated Susan Smith who was appointed the Association of Air Medical Services (AAMS) Region 6 Representative.</p> <p>Michael Berg reported that the FBI Background Check Fingerprinting Process will become effective July 1 of this year. Twelve thousand fingerprint cards will be distributed to the Regional Councils today. Notifications will be sent out and information will be posted on the OEMS website. This process will not be backdated.</p> <p>From a regulatory packet standpoint, the Financial Assistance Review Committee (FARC) regulatory packet will go before the Board of Health for review in June as a Fast Track. The Practitioner’s Signature packet is still waiting to be signed by the Secretary of Health and Human Services.</p> <p>Michael Berg also updated everyone on the K specs which will expire on September 30, 2015. The information regarding this will be posted on the OEMS website.</p>	<p>An email will be sent to the committee once a decision has been made about the committee composition.</p>
Model State Guidelines Update – Tm Perkins:	<p>Tim stated that an email about the FAA rules was sent out on April 21 to inform everyone that the rules governing air medical services that were to be effective on April 22 has been delayed for a year. So stay tuned until April 22, 2015.</p>	
Project Synergy Work Group Update – Susan Smith/Bert Bogue/Greg Jones/ Denise Baylous:	<p>Susan, Greg, Bert and Denise are working on a new project synergy and two conference calls have been held since the February meeting. The new project synergy will look at stroke and STEMI patients. From the first conference call, they decided to limit their focus and start with STEMIs by comparing time from ground and air from time of first EMS contact to the time the patient reaches PCI. Susan has been in touch with Carol Pugh of OEMS and they will continue to work with Carol on future projects. They want to ensure that the data submitted in VPHIB is as accurate as possible in order to compile accurate reports.</p> <p>Greg said they plan to give Carol one call to try to extract the data from and see if a report can be created.</p>	
Virginia Helicopter EMS Program Development – Tim Perkins:	<p>The WeatherSafe application continues to grow in the amount of data submitted. Tim reported that there were 585 entries in the first quarter of 2014, and 70% of those entries (415) were inter-facility transports. The total number of turndowns is an increase from 603 entries in the first quarter of 2013. This data continues to show dedication to the program and to maintaining safety of Medevac personnel & equipment.</p> <p>Tim requested that all hazard information is entered in the VHEMS system before being emailed to him.</p>	<p>Agencies are asked to submit all hazard information into the VHEMS system prior to emailing Tim.</p>

	<p>As for the Landing Zone information, Tim has Googled all of the landing zones and posted pictures of them on the WeatherSafe site.</p> <p>He also stated that if you are unable to see an agency's base information, you have to subscribe to them.</p> <p>a. Presentation of letter for EMS agencies, dispatch centers and referring facilities A letter was drafted by Tim and Anita reminding hospitals, Medevac dispatch centers and 911 centers of what Helicopter EMS is, why data is collected and why the need for notifying agencies of previous turndowns. Anita gave the letters to the respective area agency committee member for distribution.</p>	
Program Announcements:	<p>Susan Smith, Carilion Clinic LifeGuard – No report.</p> <p>Denise Baylous, Nightingale – Navy aircraft communications have improved with training.</p> <p>Kelly Keener, PHI Air Medical – Erik Rohde has resigned as the Regional Director of the North East. He has left the air medical industry and working for AMR in California. Fairfax helipad –two cranes are due to come down this month and the south patient tower is scheduled to reopen in June.</p> <p>Jay Cullen, VSP – Nothing new for State Police, but Virginia Guard has starting operations out of Chesterfield Airport. It has become a very busy heliport. Be advised that there is more helicopter activity. State Police is now participating in WeatherSafe and Anita thanked Jay for his role in getting the agency on board.</p> <p>Brian Solada, LifeEvac/Air Methods – VCU will be hosting a TNATC/TPATC class in October. New Business:	<p>a. East Coast Helicopter Operations Group – Jon Kaminski Jon is with Fairfax County and Fairfax hosted a barbeque for area agencies last year and ended up with 13 aircraft in the area. While they were all together they decided to start the ECHO Group. It grew by word of mouth. On April 29, 2014, Helicopter Association International (HAI) hosted the Inaugural Spring Conference. There were more than 70 members of ECHO present from more than 2 dozen law enforcement, military and EMS agencies from North Carolina to New Jersey. Currently there are about 300 members from approximately 30 agencies and membership is free. Florida has also recently joined the Group. Many training opportunities will be held. Maryland State Police has agreed to hold the next conference in September which will be a fly in. There is no registration fee. They are also doing a flight crew exchange program. And they are working with the military to do water egress training.
