Discussion: Mr. Eckstein reviewed reported fee revenues for the last five years FYs 2010-14)

breaking out the revenue stream breaking down revenue by waterworks paying at the fee cap and waterworks paying at the per connection rate. He and Ms. Munford discussed expenditures and debit/balances for each of the five years reported. Mr. Pellei provided the committee members with the language on the Technical Assistance Fees contained in §32.1-171.1 COV and sections 12VAC5-600-50 and 12VAC5-600-60 of the Regulations. After deliberation, a motion was made by Mr. Herzog that ODW explore the option of having the Technical Assistance Fees and the state-match to ODW's federal EPA grants be deposited into accounts at the Virginia Resource Authority. It was seconded by Mr. Higgins. There was no discussion. The motion carried unanimously.

Discussion: Mr. Herzog raised questions on DEO's draft VWP Regulations and on safe yield of

water intakes. Mr. Herzog related that there has been a lot of discussion on the draft VWP regulations at the DEQ Citizen Advisory Group meetings. The last meeting of the CAG was the week before this WAC meeting. Some areas of discussion at the DEO CAG have included:

- How will safe yield be determined for intakes requiring a VWP permit?
- How will safe yield be determined for grandparented intakes not requiring a VWP permit?
- With VDH proposing to eliminate "safe yield" from the waterworks regulations but safe yield still being a component of "permitted capacity", how will the source capacity be determined for waterworks with grandfathered intakes that do not require a VWP permit?
- Has VDH already established safe yields for grandfathered intakes?
