Agenda Item: Chair's Report

Discussion: Mr. Hammond reported in Mr. Aulbach's absence and provided the

following updates:

Mr. Elmer Handy has retired from the Committee resulting in the need for the selection
of a new Vice Chair. This action item was deferred until the next meeting due to the lack
of a quorum.

- The new Office of Drinking Water Legal Affairs Assistant position as been filled and the new employee is set to begin on August 25.
- The Training and Security Manager position is still in the recruitment process. Second interviews are scheduled for the week of July 25. Hopeful start date of selectee end August.
- The vacant State Revolving Fund Engineer position has been filled with Roy Soto. Mr. Soto was formerly the ODW Source Water Protection Engineer. That position is now open for applications.
- The candidate selected to fill the vacant Executive Secretary Senior position is undergoing a background check.
- The new Geographic Information Systems position is also currently under recruitment.
- ODW continues to discuss lead in drinking water with EPA and Virginia officials. ODW is also providing assistance to the VDH Office of Environmental Health Services (OEHS) regarding coal ash pond closures across the Commonwealth and adjacent private drinking water wells.

# Agenda Item: Revised Total Coliform Rule update

*Discussion*: Mr. Hammond updated the Committee as follows:

- Revised Total Coliform Rule (RTCR) adoption is continuing to move forward. On June 1st, VDH received its federal consistency review letter from EPA Region III. The RTCR adoption package is now under review by Virginia's Office of the Attorney General.
- The first month of RTCR compliance determinations using SDWIS went smoothly.
   To date, ODW staff has performed two Level 2 assessments as a result of TC+ /
   EC+ sampling (i.e., an E. Coli PMCL violation). Based upon historical experience,
   ODW estimated that approximately five Level 2 assessments would be performed
   by staff over a calendar year. ODW is cautiously optimistic that the number of
   required Level 2 assessments will not continue to grow exponentially over the
   remainder of Calendar Year 2016.

# Agenda Item: Lead and Copper Rule update

*Discussion:* Mr. Hammond provided the following information:

- ODW continues to work with EPA Region III to address lead and copper rule implementation questions from EPA Headquarters.
- Thirteen waterworks remain on EPA's lead priority list. These waterworks are currently performing follow up monitoring in response to a lead action level exceedance.
- Thanked the WAC members for their review and comments on ODW's draft letter to waterworks owners regarding EPA's increased oversight of the lead and copper rule. ODW will be moving forward with sending letters to waterworks owners.

#### Agenda Item: Waterworks Regulations update

Discussion: Mr. Hammond provided the following information:

- The revision of the Revised Total Coliform Rule (RTCR) received EPA and Office of the Attorney General concurrence in June. It is currently under review in the Health Commissioner's Office and should receive final adoption in Fall of this year.
- The periodic review of the Regulations received no comments during the Public Comment period in May. The waterworks Regulations will remain as is for now.
- The full Regulation review/revision process started in 2015 will resume later this year with the work done so far sent to the Regulations Advisory Panel and the WAC for their review and comment. The 18-24 month process has three steps: 1) issuing a Notice of Intended Regulatory Action, 2) drafting proposed Regulations, 3) adopting the final Regulations. The target for completion for this review/revision is winter 2017.

#### Agenda Item: DCLS Update

Discussion: Mr. Glowacky informed members of the following items:

- DCLS continues to receive Zika patient samples. Currently we have received 818
  patient samples that fit the profile for testing. 20 of these samples were presumptive
  positive. Last week we received our first mosquito samples. These samples were found
  to be negative for Zika virus.
- As part of a biomonitoring grant funded through the CDC, DCLS has begun the
  monitoring of urine samples for metals and perchlorate that were obtained from
  community college students. The study is being performed to determine if there is a
  relationship between water source and these chemical burdens.
- As part of the Food Emergency Response Network (FERN), DCLS is preparing for potential samples from the Democratic National Convention next week.
- Laboratory Certification Update: Commercial lab accreditation has an effective date of September 1, 2016 for the implementation of the 2009 TNI standard. Non-commercial certification is currently in its final public comment period and updates to this regulation are also expected to be effective on September 1, 2016. Non-commercial laboratory proficiency testing frequency will be reduced from twice per year to only once.
