Agenda Item: WAC Representatives Meeting with Health Commissioner Update Discussion:

On April 3, 2017, David Raines, Jesse Royall and David Van Gelder met with the State Health Commissioner at the Health Department Central Offices in the Madison Building in downtown Richmond. The purpose of the meeting was to reintroduce the Commissioner to the WAC. WAC members present at the meeting described it as positive and supportive. The Commissioner shared with them the budgetary pressure placed on VDH as a whole. In light of that and the likelihood of decreased federal funding from the EPA, members discussed that another review of the fee structure may be necessary to keep ODW fully funded. The Commissioner noted a desire to attend future WC meetings.

 - Review of Section 10. Definitions and Dr. Boardman's comments ongoing
 - Contact with Registrar's Office
 - Repeal sections 20-Authority for regulations, 30-Purpose of regulations, 60-Compliance with the Administrative Process Act.
 - Remove section 90-Reserved
 - Will perform a prepublication review of the entire draft in June 2017.
 - Met with Office of Environmental Health Services concerning Private Well Regulations (undergoing update), to coordinate requirements in WW Regulations sections
 - 475-Removal of wells from service
 - 476-Reactivation of wells
 - 840-Groundwater sources
 - New section for <u>Drinking water advisories</u> in development
 - Must coordinate with federal requirements in section 540-Public notices

- Legal authority, OCOM and OEM review and approval required
- Regs review started at Part 2, 12VAC5-590-600 and continued through and including Part 3, 12VAC5-590-840.
 - Points of discussion included:
 - Numerous minor, non-substantive changes discussed and made
 - Defining timeframes rather than using generic terms such as immediately or promptly
 - Residential fire protection systems
 - Groundwater sources
