<b>2015 Annual Report / Quarterly Reports</b>	<p>Dwight reported that updates have been made to the 2015 TPIC Annual Report. I am awaiting approval to post on our website. Since the supplemental tables are de-identified, then we will have to send out the new Agency ID's to everyone.</p> <p>The 2016 report will not be available in March, but we are preparing to have it available at the next Governor's Advisory Board meeting in May. We are going to attempt to have the Q1 2017 report available in May as well. Then, we will go on a quarterly system in which reports will be available. Forrest commented that this time frame would be highly ambitious. John commented that it sounds much better that it's been and it sounds good that data will be available sooner. Forrest commented that if the 2017 report is not available in May, then the data would be available after that in June.</p>	
<b>Data Quality Report</b>	<p>Dwight reported that the VPHIB system is back up and he can pull data to update the data quality report. He will be working on updating the report and will work on getting it distributed when it is available. Report will be grouped by regions. After we start sending out, then the reports can be sent out on a monthly basis.</p> <p>Forrest asked if there have been any comments on the OEMS level on the simplified GCS score. Forrest will bring up at the next Medical Direction Committee.</p> <p>Forrest asked about the ability to setup reports in VPHIB that agencies can run daily to see the ongoing frequency of calls that meet the trauma triage criteria. When the data quality report goes out, then the report will be made available to all agencies statewide and then they can run the report to identify the details with their incidents. Forrest recommended putting the instructions on the data quality report so that they know how to access the report to verify your data. Dwight reported that he will include methodology in the report as well.	
<b>Linking Registries</b>	Forrest asked about linking our registries and how close we are to that goal. Dwight reported that we are still working towards getting to that goal.	
<b>Trauma Criteria</b>	Dwight reported that the committee has had questions with the trauma criteria. Before the meeting, he sent out a report for 2016 that shows the primary impression codes that agencies are using in the state. He wanted everyone to know the information. The information will be brought up at the next meeting to discuss.
