Mr. Mitchell was present to address the Board. Mr. Mitchell gave a brief background of his professional career and the circumstances surrounding his disciplinary case. Mr. Mitchell respectfully requested the Board consider lesser sanctions than was contained in the IFF summary recommendation.

Regarding File number 2009-01548, Dennis Troy Mitchell, the Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigative file, transcripts and exhibits, the Summary of the Informal Fact-Finding Conference as well as the Section's recommendation. Mr. Boyd moved to accept the Summary of the Informal Fact-Finding Conference as to the facts, which cites the following violations of the Board's regulations: 18VAC10-20-750 (Count 1); 18VAC10-20-740.B (Count 2); and 18VAC10-20-740.C (Count 3). Mr. LeMay seconded the motion which was unanimously approved by members: Boyd, De León, Harris, Finn, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson and Stiles. As the reviewing Board member, Mr. Fauber was not present during the discussion or vote.

Ms. Perkins indicated that there have been no prior disciplinary actions against Mr. Mitchell. After discussion, Mr. Stephenson moved to reject the recommendation of the Presiding Board Member and recommended: no fine for the violation contained in Count 1; \$1,250 fine for the violation contained in Count 2; \$1,250 fine for the violation contained in Count 3, for a total monetary fine of \$2,500; as well as probation of Mr. Mitchell's architect license for a period of three years. During the probation, any infraction of the Board's regulation may result in further disciplinary sanctions or suspension. Ms. Stiles seconded the motion which was unanimously approved by members: Boyd, De León, Harris, Finn, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson and Stiles. After discussion, Mr. Boyd moved to reject the recommendation of the Presiding Board Member and recommended a duplication of the penalties determined in File #2009-01548: no fine for the violation contained in Count 1; \$1,250 fine for the violation contained in Count 2; \$1,250 fine for the violation contained in Count 3, for a total of \$2,500 in monetary penalties; as well as probation of Mr. Mitchell's architect license for a period of three years to serve concurrently with the probation recommended in File #2009-01548. During the probation, any infraction of the Board's regulation may result in further disciplinary sanctions or suspension. Mr. LeMay seconded the motion which was unanimously approved by members: Boyd, De León, Harris, Finn, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson and Stiles. As the reviewing Board member, Mr. Fauber was not present during the discussion or vote.

Regarding File Number 2009-02762, Frederick Alan Gibson, the Board members reviewed the Consent Order as seen and agreed to by Mr. Gibson. Mr. Stephenson moved to accept the Consent Order which cites the following violation: 18VAC10-20-370.D.2 (Count 1). For this violation, Mr. Gibson agrees to pay the following monetary penalties: \$600.00 for the violation contained in Count 1; and \$150.00 in Board costs, for a total monetary penalty of \$750.00. In addition, Mr. Gibson agrees to complete at least eight (8) classroom hours of continuing education pertaining to boundary surveying and/or other equivalent course approved by the Board and provide proof of attendance and successful completion within twelve (12) months of the effective date of this order. **Recess**

Mr. Costello was present to address the Board. Mr. Costello explained his request for guidance from the Board on the two issues discussed.

Ms. Nosbisch informed the Board that the request for interpretation from Mr. Costello had been discussed at the PE and Land Surveyors Section meetings. Both Sections agreed that there is a distinct difference between "completing" or "replicating" a plan (18VAC10-20-740.D) and correcting or modifying. Regulation 18VAC10-20-740.D specifically addresses "completing" or "replicating" and does not specifically address "correcting or modifying" a plan.

Nonetheless, if a professional is using a plan to correct or modify and existing structure, they are taking responsibility for the modification and ensuring that the correction or modification has no adverse ramification on the rest of the design. However, the "corrected or modified" plan should note sourcing information, and that field verification of the information from the original plan must be performed.

The Board concurred with the PE and Land Surveyor Sections. Mr. LeMay moved to accept the proposed response by Ms. Nosbisch to Mr. Costello. Mr. Harris seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.

Ms. Nosbisch informed the Board that the second request for interpretation from Mr. Costello had also been discussed at the PE and Land Surveyors Section meetings. Mr. Costello's request dealt with the Virginia High Voltage Line Safety Act, certain sections of the National Electric Code and the responsibility of surveyors to include this information on subdivision plans or "house permit plans or plots."

The Board agreed that this information would affect the licensee differently

depending on whether they were performing a physical survey or a design; and that if a “professional” is involved in the design, they need to be aware of applicable laws, regulations and ordinances.

Mr. Johnson moved to accept the proposed response by Ms. Nosbisch to Mr. Costello. Mr. Harris seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.

Ms. Nosbisch informed the Board that the request for interpretation regarding Code Evaluation Reports and their adherence to Board regulations had been discussed at the PE Section meeting. The Section reviewed several sample evaluation reports and documents provided by the petitioner. The Section agreed that pursuant to §54.1-402.A.9, if a Professional Engineer or Architect is not required on a project, the Code Evaluation Reports are permissible. If a Professional Engineer or Architect is required, then the licensee is responsible for the design of the project and could use the Code Evaluation Reports for material selection. The application of the standard design must be signed by a Virginia licensed professional.

**Request for Board Interpretation on Code Evaluation Reports**

Mr. Johnson moved to have the Board’s response state “if there is a design using the materials, application must be signed/sealed by the professional.” Ms. Rinner seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.

Ms. Nosbisch informed the Board that the request for interpretation from Mr. Dunlap had been discussed at the PE and Land Surveyors Section meetings. The correspondence received from Mr. Dunlap, concerned VDOT/Fairfax County and their requirement for a Professional Engineer to sign/seal certain documents. Mr. Dunlap holds a Land Surveyor B license and feels that he should be allowed, according to statute, to sign/seal documents that contain engineering incidental to his project. Mr. Dunlap explained that in one instance he was permitted to design the road changes, but was not allowed to seal/stamp the road markings. The Sections had established that the Board can determine whether a licensee is qualified or not, but cannot tell the permitting agency what to do.

**Request for Board Interpretation from Chuck Dunlap, LS – Regarding VDOT**

Mr. Stephenson moved to draft a response to Mr. Dunlap, copying VDOT, stating that a Land Surveyor B may be qualified to sign/seal such work. Mr. Harris seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.

The Board was provided correspondence from VDOT concerning the signing and sealing of plans by Professional Engineers. VDOT also provided a list of documents that are now required to be signed and sealed by a Professional Engineer.

**Discussion of VDOT Professional Signing and Sealing Implementation**

Discussion was held and it was determined that the initial correspondence was intended as internal requirements for VDOT. However, it seems VDOT may mistakenly apply internal requirements to external professionals. Such may have been the case with Mr. Dunlap.

The Board determined that more discussion was needed on this topic. Ms. Rinner moved to table the discussion and discuss in Section meetings. Mr. Johnson seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.

The Board members recessed from 11:28 a.m. until 11:45 a.m.

**Recess**

Mr. Nick Christner, Deputy Director, Compliance and Investigations, gave a presentation on the structure of the Compliance and Investigations Division, the complaint process and enforcement process.

**Compliance & Investigations Enforcement Training**

Mr. Courtney provided the Board members with training on the Regulatory Review process.

**Regulatory Review Training**

The Board members were provided with a comprehensive report of enforcement activity since the last Board meeting.

**Comprehensive Report of CID Activity**

The Board members were provided with financial statements from June 2009 for informational purposes.

**Review of Board Financial Statements**

Ms. Nosbisch informed the Board that a motion was needed to file the Notice of Intended Regulatory Action (NOIRA) for the regulatory review. Mr. Boyd moved to file the NOIRA. Mr. Fauber seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.

**Other Business**

Ms. Nosbisch reported on the online transactions that the Board is receiving. From May to September the number of transactions has risen from just over 500 to over 4,000.



Ms. Nosbisch informed the Board that a motion was needed to elect a funded delegate to the NCEES Joint NE/Southern Zone Interim Meeting. Mr. Johnson moved to nominate Ms. Nosbisch. Mr. De León seconded the motion which was unanimously approved by members: Boyd, De León, Fauber, Finn, Harris, Johnson, LeMay, McIntyre, Rinner, Scherzer, Stephenson, and Stiles.


