Call to Order

Mr. Crowther moved to approve the agenda. Mr. Scherzer seconded the motion which was unanimously approved by members: Crowther and Scherzer.

Approval of Agenda

There was no public comment.

Public Comment

The section members discussed proposed changes to ASLA's LAAB Discussion of accrediting requirements. Specifically, the section members discussed the Proposed ASLA's Board of Director's acceptance of a recommendation from the Task Changes to Force on Accreditation and Reciprocity to authorize the LAAB to accredit LAAB Scope non-degree granting programs.

The section members agreed that accrediting non-degree granting programs is not in the best interest of the future of landscape architect licensure. The section members agreed by consensus that a letter be sent to the ASLA expressing their concern that, were the LAAB to accredit non-degree granting programs, future landscape architects may not have the requisite education to competently practice landscape architecture. The section members do not support the proposed change to allow the LAAB standards to include accrediting non-degree granting programs. The Section agreed by consensus to have staff draft a letter to the ASLA, stating that they do not support the changes.

Mr. Scherzer inquired as to whether travel authorizations were approved for **CLARB Update** board members to attend NCARB and NCEES meetings and conferences. Staff indicated that as NCARB and NCEES typically provide funding for the Executive Director and a board member to attend, they are more likely to be approved than travel funded by the agency.
