Chair Diane Quigley called the meeting to order at 10:06 AM.

Call to Order

A motion was made by Mr. Lewis and seconded by Mr. Pruitt to approve the agenda. The motion passed unanimously. Members voting "Yes" were Critzer, Lewis, James, Pruitt, Harry and Quigley.

Mr. McCanna was present and addressed the Board. A motion was made by Mr. Pruitt and seconded by Mr. Myers to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference to approve the trainee license with an amendment to require an agreement for licensure with Mr. McCanna reporting to the Board semi-annually for a period of two years. The motion failed. Members voting "Yes" were Pruitt, Myers and Quigley. Members voting "No" were Lewis, Harry and Critzer. Mr. James abstained from voting.

A motion was made by Ms. Critzer and seconded by Mr. James to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference to approve the trainee license with an amendment to require an agreement for licensure with Mr. McCanna reporting to the Board semi-annually for a period of two years and the agreement from Mr. McCanna that he will not apply for a licensed residential appraiser license for a period of two years. The motion passed by majority vote. Members voting "Yes" were Pruitt, Myers, Quigley, Critzer and James. Members voting "No" were Lewis and Harry.

The motion passed unanimously. Members voting "Yes" were Lewis, Myers, Critzer, Quigley, James and Harry. Mr. Pruitt abstained from voting in this matter.

A motion was made by Mr. James and seconded by Mr. Harry to reject the recommendation contained in the Summary of the Informal Fact-Finding Conference to impose a monetary penalty of \$500.00 for the violation of Count 1 and instead impose no monetary sanction. The motion passed unanimously. Members voting "Yes" were Lewis, Myers, Critzer, Quigley, James and Harry. Mr. Pruitt abstained from voting in this matter.

A motion was made by Mr. James and seconded by Mr. Harry to reject the recommendation contained in the Summary of the Informal Fact-Finding Conference to impose a monetary penalty of \$500.00 and probation of license until successful completion and passing of a 15 hour USPAP classroom course for the violation of Count 2 and instead impose no sanctions. The motion passed by majority vote. Members voting "Yes" were Lewis, Myers, James and Harry. Members voting "No" were Quigley and Critzer. Mr. Pruitt abstained from voting in this matter.

In the matter of File Number 2009-04360, Anthony A. Tate, the Board reviewed the Consent Order as seen and agreed to by Mr. Tate. A motion was made by Mr. Lewis and seconded by Mr. Harry to accept the proposed Consent Order wherein Mr. Tate admits to a violation of 18 VAC 130-20-180.K.4 (Count 1) of the Board's 2008 Regulations, and a violation of 18 VAC 130-20-180.K.5 (Count 2) of the Board's 2008 Regulations, and agrees to no monetary penalty for the violation contained in Count 1, and \$350.00 for the violation contained Count 2, as well as \$150.00 in Board costs for a total of

A motion was made by Mr. Myers and seconded by Mr. Harry to accept the proposed Consent Order wherein Mr. Alexander admits to a violation of 18 VAC 130-20-180.K.4 (Count 1) of the Board's 2008 Regulations, a violation of 18 VAC 130-20-180.K.5 (Count 2) of the Board's 2008 Regulations, and a violation of 18 VAC 130-20-180,B.1.a (Count 3) of the Board's 2008 Regulations and agrees to a monetary penalty of \$500.00 for the violation contained in Count 1, \$350.00 for the violation contained in Count 2, and \$150.00 for the violation contained in Count 3, as well as \$150.00 in Board costs for a total of \$1,150.00. In addition, for violation of Count 1, Alexander agrees to complete the fifteen (15) classroom hour USPAP The USPAP course shall not be completed on-line. course. Alexander agrees to provide the Board with proof of attendance and successful completion within six (6) months of the effective date of this order. Further, if Alexander provides proof to the Board, within six months of the effective date of this order, that he has successfully completed the fifteen (15) hour USPAP course in accordance with the Maryland order, the above-referenced USPAP course requirement will be waived. It is acknowledged that satisfactory completion of the above-referenced USPAP course will not count towards any continuing or pre-license education requirements needed for license renewal, reinstatement, or license upgrade. The motion passed unanimously. Members voting "Yes" were Lewis, Myers, Critzer, James, Quigley and Harry.

As the Board member who reviewed the file, Mr. Pruitt did not participate in the discussion or vote on this matter.

In addition, for the violation of Count 1, Callison agrees to suspension of license for a minimum of (60) days. Further, for violation of Count 1, during the minimum 60 day suspension period, Callison agrees to complete a fifteen (15) classroom hour USPAP course within 60 days of the effective date of the Order. If Callison fails to complete the USPAP course within 60 days, the license suspension will continue until he provides evidence of completion of the course. The USPAP course shall not be completed on-line. Callison agrees to provide the Board with proof of attendance and successful completion of the USPAP course. It is acknowledged that satisfactory completion of the above-referenced courses will not count towards any continuing or pre-license education requirements needed for license renewal, reinstatement or license upgrade. If Mr. Callison does not accept the counter-offer within 10 days, the case will proceed to an Informal Fact-Finding Conference. The motion passed unanimously. Members voting "Yes" were Lewis, Myers, Critzer, James, Quigley and Harry.

As the Board member who reviewed the file, Mr. Pruitt did not participate in the discussion or vote on this matter.

A motion was made by Ms. Critzer and seconded by Mr. Harry to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference and find a violation of 18 VAC 130-20-180.D (Count 1) of the Board's 2008 Regulations, a violation of 18 VAC 130-20-180.D (Count 2) of the Board's 2008 Regulations, a violation of 18 VAC 130-20-180.D (Count 3) of the Board's 2008 Regulations, and a violation of 18 VAC 130-20-180.E (Count 4) of the Board's 2008 Regulations. A motion was made by Mr. James and seconded by Mr. Harry to reject the recommendation contained in the Summary of the Informal Fact-Finding Conference and instead impose license revocation for Counts 1-4. The motion was withdrawn.

A motion was made by Ms. Critzer and seconded by Mr. Harry to reject the recommendation contained in the Summary of the Informal Fact-Finding Conference for the violations contained in Counts 1 through 4 and instead impose a monetary penalty of \$500.00 for the violation contained in Count 1, \$500.00 for the violation contained in Count 2, \$500.00 for the violation contained in Count 3, and \$500.00 for the violation contained in Count 4 for a total of The Board also imposes the following sanctions: Suspension of license for a period of twelve (12) months for violation of Counts 1 through 4. In addition, Hatte is placed on probation until Hatte has presented evidence acceptable to the Board that he has successfully completed 150 classroom hours of the prelicense education required for the licensed residential classification. Such courses shall be offered by a member of the Appraisal Foundation or from one approved by the Board. Such courses shall not be distance education courses. It is acknowledged that satisfactory completion of the above-referenced courses will not count towards any continuing education requirements for renewal of license, reinstatement, or to upgrade a license. Failure to comply with all terms of the Order within the specified time will result in the automatic suspension of Hatte's license until such time as there is compliance with all terms of the Order. The Board voted to increase the suspension and the education due to the seriousness and severity of the violations. The motion passed unanimously, Members voting

"Yes" were Lewis, Myers, James, Critzer, Quigley and Harry.

A motion was made by Mr. Harry and seconded by Ms. Critzer to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference to impose no monetary penalty for the violation contained in Count 1, and \$500.00 for the violation contained in Count 2, for a total of \$500.00. The Board also imposes the following sanctions: Probation of license for a period of 12 months. While on probation, Hess shall submit three (3) reports per quarter to the Board for review. If Hess fails to comply with this provision, or submits reports that fail to comply with USPAP, the failure to comply with the terms will result in the automatic imposition of license suspension for a period of 12 months. Failure to comply with all terms of the Order within the specified time will result in the automatic suspension of Hess' license until such time as there is compliance with all terms of the Order. The motion passed by majority vote. Members voting "Yes" were Critzer, Myers, Lewis, James and Harry. Member voting "No" was Pruitt.

The motion passed unanimously. Members voting "Yes" were Myers, Critzer, Lewis, Pruitt, James, Quigley and Harry.
