**Introduction of Counsel** 

Arrival of Ms. Burgin

In the matter of File Number 2004-00425, Robert A. Garrett, the Board reviewed the record which consisted of the Consent Order. Mr. Garrett was not present. A motion was made by Mr. Harry and seconded by Mr. Mullins to ratify the Consent Order finding a violation of the Board's 1998 Regulation 18 VAC 130-20-180(D) and imposing a monetary penalty of \$500 for this violation. The motion passed unanimously. Members voting "Yes" were Castle, Call, Fuller, Burgin, Harry, Mullins, and Whaley. As the presiding Board member at the Informal Fact-Finding Conference, Mr. Lewis was not present during the discussion or vote.

File Number 2004-00425, Robert A. Garrett

In the matter of File Number 2005-00073, Thomas E. F. Saltz, the Board reviewed the record, which consisted of the application file, transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding officer. Mr. Saltz was not present. A motion was made by Mr. Harry and seconded by Mr. Whaley to accept the recommendation of the hearing officer and approve Mr. Saltz's application for licensure as a real estate appraiser trainee. The motion passed unanimously. Members voting "Yes" were Castle, Call, Fuller, Burgin, Harry, Lewis, Mullins, and Whaley.

File Number 2005-00073, Thomas E. F. Saltz

In the matter of File Number 2005-00280, Bobby G. Dalton, the Board reviewed the record, which consisted of the application file, transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding officer. Mr. Dalton was not present. A motion was made by Mr. Harry and seconded by Ms. Burgin to reject the recommendation contained in the Summary of the Informal Fact-Finding Conference and to deny Mr. Dalton's application for licensure as a real estate appraiser trainee for several reasons. Specifically, the criminal activity for which Mr. Dalton was convicted raises concerns due to the fiduciary relationships involved in the real estate appraisal profession, and the criminal act demonstrated a lack of trust and responsibility which is required in the profession. Additionally, Mr. Dalton has shown a lack of remorse or acceptance of responsibility for the crime, as he stated at the Informal Fact-Finding Conference that at the time of the activity, he was young and had no expectation of getting caught. Finally, the Board considered the criteria provided in § 54.1-204 of the Code of Virginia in looking at the totality of the circumstances. The motion passed unanimously. Members

voting "Yes" were Castle, Call, Fuller, Burgin, Harry, Lewis, Mullins, and Whaley.

In the matter of File Number 2005-00463, Jeffrey C. Eisenbeiss, the Board reviewed the record, which consisted of the application file, transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding officer. Mr. Eisenbeiss was not present. A motion was made by Mr. Whaley and seconded by Mr. Lewis to reject the recommendation contained in the Summary of the Informal Fact-Finding Conference and to deny Mr. Eisenbeiss' application for licensure as a licensed residential real estate appraiser due to the recency of the conviction and the fact that he is still on probation. Further, the Board considered the criteria provided in § 54.1-204 of the Code of Virginia in looking at the totality of the circumstances. The motion passed unanimously. Members voting "Yes" were Castle, Call, Fuller, Burgin, Harry, Lewis, Mullins, and Whaley.

Mr. Castle discussed disciplinary actions involving certified instructors. Ms. Martine pointed out 18 VAC 130-20-150 regarding the Board's discretion to deny renewal or reinstatement. After discussion, the Board agreed by consensus to direct staff, during the investigatory process, to determine if a real estate appraiser holds a certification as an instructor.

A motion was made by Mr. Call and seconded by Ms. Fuller to adjourn the meeting at 12:12 p.m. The motion passed unanimously. Members voting "Yes" were Castle, Call, Fuller, Burgin, Harry, Lewis, Mullins, and Whaley.
