# **Subject matter and intent**

The purpose of the proposed action is to amend and reissue a VPDES general permit for discharges from pesticides applied to surface waters to control pests, and/or applied to control pests that are present in or over, including near, surface waters. This permit expires on December 31, 2018 and needs to be reissued so pesticide operators can continue to have coverage in order to apply chemical pesticides that leave a residue in water, and all biological pesticide applications that are made in or over, including near, waters of the United States.

The basis for this regulation is § 62.1-44.2 et seq. of the Code of Virginia. Specifically, § 62.1-44.15(5) authorizes the Board to issue permits for the discharge of treated sewage, industrial wastes or other waste into or adjacent to state waters and § 62.1-44.15(7) authorizes the Board to adopt rules governing the procedures of the Board with respect to the issuance of permits. Further, § 62.1-44.15(10) authorizes the Board to adopt such regulations as it deems necessary to enforce the general water quality management program, §62.1-44.15(14) authorizes the Board to establish requirements for the treatment of sewage, industrial wastes and other wastes, § 62.1-44.16 specifies the Board's authority to regulate discharges of industrial wastes, § 62.1-44.20 provides that agents of the Board may have the right of entry to public or private property for the purpose of obtaining information or conducting necessary surveys or investigations, and § 62.1-44.21 authorizes the Board to require owners to furnish information necessary to determine the effect of the wastes from a discharge on the quality of state waters.

Section 402 of the Clean Water Act (33 USC 1251 et seq.) authorizes states to administer the NPDES permit program under state law. The Commonwealth of Virginia received such authorization in 1975 under the terms of a Memorandum of Understanding with the U.S. EPA. This Memorandum of Understanding was modified on May 20, 1991 to authorize the Commonwealth to administer a General VPDES Permit Program.

#### **Purpose**

This proposed regulatory action is needed in order to establish appropriate and necessary permitting requirements for discharges of wastewater from chemical pesticides that leave a residue in water, and all biological pesticide applications that are made in or over surface waters. These discharges are considered to be point sources of pollutants and thus are subject to regulation under the VPDES permit

program. The permit regulation specifies requirements that protect water quality below the discharge and that is essential to protect the health, safety, or welfare of citizens.

The primary issue that needs to be addressed is that the existing general permit expires on December 31, 2018 and must be reissued in order to continue making it available after that date. Other issues that need consideration are:

- Whether the permit should not include coverage for or add restrictions for weed, algae, or pathogen control applications in tidal waters;
- Clarifying which operator (decision maker or applicator) must maintain a pesticide discharge management plan. Currently all operators that exceed certain thresholds must maintain a pesticide discharge management plan possibly resulting in duplicate PDMPs with different discharge management practices;
- Whether the narrative technology and water quality limits, monitoring requirements and other conditions (PDMP, special conditions and conditions applicable to all permits) of the permit are still appropriate; and
- Any other issues raised during public comment and technical advisory committee discussions.

One alternative would be to require registration statements (notices of intent) from each operator or a certain class of operators. However, the department believes the submittal of registration statements will not provide the Commonwealth with any more information than is currently administered by the Virginia Department of Agriculture and Consumer Services. The current method of coverage that does not require registration statements is the least intrusive and least costly alternative for small businesses and achieves the purpose of the regulation.
