To account for the legislative change to the Code of Virginia, a sentence specifying that a VSMP authority application package shall include contracts with third-party professionals who hold certificates of competence in the appropriate subject areas to carry out any or all of the responsibilities required of a VSMP including plan review and inspection but not including enforcement.
