This regulatory action will amend the Regulated Medical Waste Management Regulations under 9VAC20-120. Currently, transporters of regulated medical waste are required to register with the Department of Environmental Quality (Department). This registration is duplicative of the federal registration requirements and unnecessary as the information received from the registration under 9VAC20-120 can be obtained from the federal registration. As this is a duplicative requirement, this amendment will repeal the registration requirements under 9VAC20-120-480 and will amend 9VAC20-120-280 and 490 for conforming changes.

At their meeting on January 7, 2013, the Virginia Waste Management Board approved the following:

- The Board authorized the Department to promulgate the proposed amendment of 9VAC20-120 for public comment using the fast-track process established in § 2.2-4012.1 of the Administrative Process Act for regulations expected to be non-controversial.
- The Board's authorization also constituted its adoption of the regulation at the end of the public comment period provided that (i) no objection to use of the fast-track process is received from 10

or more members of the public, or any member of the applicable standing committee of either house of the General Assembly or the Joint Commission on Administrative Rules, and (ii) the Department does not find it necessary, based on public comments or for any other reason, to make any changes to the proposal.

• The Board authorized the Department to set an effective date 15 days after close of the public comment period provided (i) the proposal completes the fast-track rulemaking process as provided in § 2.2-4012.1 of the Administrative Process Act and (ii) the Department does not find it necessary to make any changes to the proposal.

The rationale for this regulatory action is to remove duplicative requirements for registration of transporters under 9VAC20-120. The information received by the registration is minimal and the same information can be obtained from the federal registration.

The proposed amendment is expected to be non-controversial, and therefore using the fast-track process is justified.

The requirements for registration of regulated medical waste transporters have been removed from the regulation. There are no viable alternatives to this proposal. The rationale for this regulatory action is to simplify the requirements for transporters.
