The regulation provides for the public’s participation in the regulatory process before the Forensic Science Board. Public participation guidelines are mandated under Virginia Code §2.2-4007.02. The proposed amendment conforms the regulation with the requirements of section B of § 2.2-4007.02. Because the amendment will permit interested persons to be accompanied by and represented by counsel or other representatives, it will encourage public participation in the regulatory process before the Forensic Science Board. It is clearly written and understandable, and the Board has followed the model Public Participation Guidelines provided for state entities. There is no negative impact for small

businesses. The Board did not identify any additional amendments that needed to be made to this regulation.
