The Advisory Board on Athletic Training conducted a periodic review of regulations for athletic trainers. In the course of the review, questions were raised by several athletic trainers in attendance about the meaning of the requirement for "direction" by a physician. Direction is specified in the statutory definition of the practice of athletic training (§ 54.1-2900) but not further defined in regulation.

"Practice of athletic training" means the prevention, recognition, evaluation, and treatment of injuries or conditions related to athletic or recreational activity that requires physical skill and utilizes strength, power, endurance, speed, flexibility, range of motion or agility or a substantially similar injury or condition resulting from occupational activity immediately upon the onset of such injury or condition; and subsequent treatment

and rehabilitation of such injuries or conditions under the direction of the patient's physician or under the direction of any doctor of medicine, osteopathy, chiropractic, podiatry, or dentistry, while using heat, light, sound, cold, electricity, exercise or mechanical or other devices.

The National Board of Certification for the Athletic Trainer has recently adopted model language for regulation. The definition of "direction" recommended by the Advisory Board and adopted by the Board is consistent with the definition in model rules and consistent with current practice that is in accordance with the law.

On October 18, 2018, the Board of Medicine amended 18VAC85-120-10 et seq., Regulations Governing the Licensure of Athletic Trainers.

The amendments are clarifying or intended for consistency with current practice and model regulatory language for the profession. There are no substantive changes, so the amendments are not expected to be controversial.

Regulations are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Section 54.1-2400, which provides the Board of Medicine the authority to promulgate regulations to administer the regulatory system:

§ 54.1-2400 -General powers and duties of health regulatory boards The general powers and duties of health regulatory boards shall be:

6. To promulgate regulations in accordance with the Administrative Process Act (§ 9-6.14:1 et seq.) which are reasonable and necessary to administer effectively the regulatory system. Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.) of this title. ...

Purpose

It is necessary to retain the current chapter because licensure and regulation of athletic trainers under the Board of Medicine is a requirement of statute. The provisions of this chapter will clarify the meaning of "direction" of an athletic trainer and will further protect the health and safety of persons who receive treatment and care from a licensed athletic trainer by clarifying the role of the doctor or dentist providing direction for such care. The regulatory change is consistent with the principle that regulations should be clearly written and easily understandable.

Substance

Pursuant to its periodic review of Chapter 120, the Board has adopted amendments to define in regulation the meaning of the word "direction" to facilitate an understanding by all parties of how an athletic trainer is allowed to practice when the licensee who is providing direction is or is not present.

Issues

1) The advantage to the public is facilitation of practice by an athletic trainer and a clearer understanding of the role of the doctor providing direction for such practice. There are no disadvantages to the public. The amendments are clarifying and consistent with current practice and interpretation.

The proposed amendments are a foreseeable result of the statute requiring the Board to protect the health and safety of citizens of the Commonwealth.

The amendments do not change the substance of the chapter; there are no alternatives that meet the essential purpose of compliance with the statutory requirement for direction which further necessitates interpretation in regulation.

One commenter on the periodic review noted a lack of information from schools and colleges on athletic trainers and included a number of websites he had visited. The Board noted the comment but did not find any specific request or recommendation for an amendment to regulation.

Another commenter requested a change to the definition of the practice of athletic training in the Code of Virginia. The Board noted the comment but has no authority to change the statute.9

Regulatory Flexibility Analysis

The term is specified in the statutory definition of the "practice of athletic training" (§ 54.1-2900) but not further defined in regulation. If a statute requires supervision or direction, the meaning is often further defined by regulation. Informally, the Board has understood that direction of an athletic trainer meant that the doctor gives verbal order (direction), if he or she is present at the time treatment or services are being provided (i.e., team doctor on the sidelines at the time of an injury). However, in many instances, the athletic trainer may be the only practitioner present and available. In those cases, the direction would be by written orders, telecommunication, a plan of care, established protocols, or by standing orders. Without the proposed definition of direction, there is uncertainty on the part of all parties — ATs, doctors, schools, third-party payers, patients, etc. — about what is required and what is not required. |
