Under Section 10, Definitions, Bioptics has been removed as it is only one of many low vision aids. Specifying all low vision aids becomes cumbersome and would require frequent revisions to the regulations as aids are added and deleted. Section 60, Driving with bioptics, has also been deleted for the same reason previously mentioned. Reference to "SSI" (Supplemental Security Income) has been deleted as it is not used by this program. Reference to case record in Section 20, Low Vision services referral has been deleted. Case records are maintained by the programs that refer a consumer for Low Vision services. Under Section 30, Eligibility, language added that eligibility for Low Vision services is determined by other department programs. Under Section 50, Financial participation, all references to endowment funds have been deleted. Endowment funds are no longer used for the purchase of low vision aids. The referring programs utilize program funding for same.
