The section of the State Plan for Medical Assistance that is affected by this action is Methods and Standards for Establishing Payment Rates—Other Types of Care: Reduction of Pharmacy Dispensing Fee (12VAC30-80-40).

The purpose of this action is to decrease the fee paid by Medicaid for the dispensing of drugs by pharmacy providers. This change is in response to a specific mandate from the 2009 General Assembly in the Appropriations Act, Chapter 781 Item 306 WW.

Effective since May 1, 2006, the Department of Medical assistance Services (DMAS) has reimbursed pharmacists \$4.00 for every drug prescription they filled for Medicaid recipients. The 2009 General Assembly directed the agency to decrease the dispensing fee paid to pharmacists from \$4.00 to \$3.75 per prescription per month.

The adjustment in Medicaid payments for prescription drugs will not affect Medicaid recipients directly in any way. The advantage of the reduction of the pharmaceutical dispensing fee is mainly to the Commonwealth in that it reduces expenditures for pharmaceutical services. The disadvantage to enrolled pharmacy providers is that this change will reduce their payment from Medicaid. However, DMAS does not anticipate that this \$0.25 change will have a negative significant impact.
