Summary of the Proposed Amendments to Regulation

As the result of a periodic review,¹ the State Board of Behavioral Health and Developmental Services (Board) proposes to update text to mirror language in § 37.2-100 of the Code of Virginia² and in 12 VAC 35-115, *Regulations to Assure the Rights of Individuals Receiving Services from Providers Licensed, Funded, or Operated by the Department Of Behavioral Health and Developmental Services*.³

Result of Analysis

The benefits likely exceed the costs for the proposed amendment.

Estimated Economic Impact

The Regulations to Govern Temporary Leave from State Mental Health and Mental Retardation Facilities are designed to: 1) inform individuals, authorized representatives, Department of Behavioral Health and Developmental Services (DBHDS) employees, community services board (CSB) staff, and pertinent stakeholders of the process and procedures related to

temporary leave from state facilities, and 2) establish the conditions for granting leave, including provisions to ensure accountability and appropriate care for persons who are on leave status.

The Board's proposal to update language to mirror the Code of Virginia and 12VAC35-115 provides improved clarity, and does not affect requirements in practice. Thus, the only impact of the proposed language amendments would be to better inform the public of current legal requirements and procedures. Consequently, the benefits of the proposed amendments exceed the costs

Businesses and Entities Affected

The proposed regulation affects the 14 DBHDS facilities, 40 Virginia CSBs, and the individuals receiving services in DBHDS facilities and their families.⁴

Localities Particularly Affected

The proposed amendments do not disproportionately affect particular localities.
