This regulatory action is necessary to bring state Child Care Subsidy Program requirements into compliance with legislation passed by the 2019 General Assembly. Chapters 166 and 218 of the 2019 Acts of Assembly make transitional child care available to former Virginia Initiative for Employment not Welfare (VIEW) participants enrolled in education and training programs. Under the current regulation, such child care assistance is available only if it enables the individual to work.
