Purpose

Complaints of child abuse or neglect involving caretakers in out of family settings are for the purpose of this chapter complaints in state licensed and religiously exempted child day centers, regulated family

day homes, private and public schools, group residential facilities, hospitals or institutions.

Virginia Code sections 63.1-25, 63.1-248.6 and 63.1-248.7:1 provide the legal authority to amend these regulations. In the first section cited, the State Board of Social Services is -- mandated to promulgate regulations for the administration of the CPS program in Virginia. The

second citation encompasses the legal basis for all CPS activities for which the local departments of social services are authorized and responsible. The final cite provides the mandate for an advisory committee of the State Board to oversee the process for investigating CPS allegations in out of family settings.

There are many issues with the investigation process for out of family CPS complaints. Such issues as timeliness, involvement of other professionals, coordination with other state agencies, et al. are being considered. As the review process is completed, changes could be recommended for any or all parts of the regulation. The review is occurring due to ongoing controversy about the efficacy of the current investigative process.

Alternatives

Please describe, to the extent known, the specific alternatives to the proposal that have been considered or will be considered to meet the essential purpose of the action.

This controversy over the out of family investigative process has been addressed previously by such actions as mandated training for CPS investigators, involvement of state CPS regional staff for case consultation, and monitoring of these cases by state staff, but the concerns persist. The advisory committee to the State Board of Social Services has been conducting inquiries into the issues for the past two years, and that committee has concluded that major changes may be needed.

Family Impact Statement

The current regulations regarding CPS out of family investigations and any proposed changes will affect families in which the child is an alleged victim of abuse or neglect by a caretaker in a designated setting outside the home. These regulations are not intrusive into family life, and by having such a process in place, parents are strengthened in their abilities to protect their children.

These regulations are intended to protect the parents' autonomy and rights to educate, supervise, and nurture their children. These regulations would have no impact on the family's marital commitment or family income.
