As the result of a comprehensive review of all of its regulations, TAX has identified numerous regulations that have been made obsolete by changes in state or federal law. As these regulations are obsolete, they are being repealed. Repeal of these regulations does not reflect a change in existing departmental policy.

23VAC10-120-50 and 23VAC10-120-60 through 67: Effective July 1, 2000, the obsolete statutes enacted in 1987 to eliminate the excess cost recovery program were repealed (2000 Acts, Chapter 419). The repealed statutes created the program to eliminate the outstanding Accelerated Cost Recovery System (ACRS) additions and the excess cost recovery repeal fund. This regulatory action will repeal this regulation that is obsolete due to the statutory change.

23VAC10-120-290; 23VAC10-120-360 through 10-120-364; 23VAC10-120-370: Effective January 1, 2004, House Bill 5018 (Chapter 3, 2004 Special Session I) added an additional statutory provision which required corporations to add back intangible and interest expenses paid to related members, rendering the regulations listed here obsolete.

The Tax Commissioner approved the repeal of these regulations on October 14, 2005.
