Section 3.2-703 of the Code of Virginia authorizes the Board of Agriculture and Consumer Services ("Board") to adopt a quarantine when the Board determines that such action is necessary to prevent or retard the spread of a pest into, within, or from the Commonwealth.

#### **Alternatives**

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. Include an explanation of why such alternatives were rejected and why this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

The alternative to this quarantine, which is intended to prevent or retard the spread of the gypsy moth from infested areas to non-infested areas, is to not have a quarantine. However, without the Virginia Gypsy Moth Quarantine, which is specific to infested areas of the state, the U.S. Department of Agriculture Animal and Plant Health Inspection Service (USDA APHIS) may step in and issue a federal, state-wide quarantine.

The gypsy moth quarantine restricts the movement of regulated articles that are capable of transporting the gypsy moth. The Virginia Gypsy Moth Quarantine places restrictions on the movement of regulated articles from those areas of Virginia that have been identified as being infested with the gypsy moth. If USDA APHIS implements a state-wide quarantine, restrictions will be placed on the interstate movement of regulated articles from the entire state, including areas of the state that are not infested with gypsy moth, placing an unnecessary burden on the citizens and businesses located in those non-infested areas. Additionally, a federal, state-wide quarantine would allow the unrestricted movement of regulated articles within the state, thereby increasing the potential for the gypsy moth to spread to non-infested areas of Virginia.

These regulations require that nurseries and timber operations located in infested areas obtain inspections and certifications for regulated articles before these articles may be moved from regulated to non-regulated areas. However, without these regulations, the U.S. Department of Agriculture Animal and Plant Health Inspection Service would issue a federal, state-wide quarantine, which would place restrictions on businesses in non-infested areas of Virginia. Under the Virginia Gypsy Moth Quarantine, those nurseries and timber operations that are in non-infested areas are not subject to the quarantine.

These regulations were amended to expand the Gypsy Moth regulated area on March 9, 2009. No significant changes to technology, economic conditions, or other factors have occurred that would necessitate modifications to these regulations. The agency recommends that the regulations stay in effect without change.
