These regulations are necessary to ensure that feed regulated under the Virginia Commercial Feed Law is properly formulated and labeled and to ensure that manufacturers' recommendations for the use of these regulated products are in accordance with methods and procedures which enhance the safety, quality, and continued availability of animal feed. These regulations meet the minimum requirements of the Code. Without the labeling requirements established in these regulations, commercial feed purchasers would not have the ability to determine the quality and quantity of the ingredients in the feed they purchase. Commercial feed purchasers must be able to ensure that the ingredients in the feed they purchase will support their animal's health and

development. Additionally, purchasers must be able to ensure that animal feed ingredients will not subsequently adulterate food products consumed by humans. As such, repealing these regulations is not a viable alternative.
