Effectiveness

The purpose of this chapter is to promote public involvement in the development, amendment or repeal of the regulations of the Department of State Police. The regulation is necessary to define and guide the public that are interested an opportunity to submit data, views, and arguments, either orally or in writing, to the agency. The regulation adopted is the the model guidelines developed by the Office of the Attorney General and is written clearly and easily understandable by outlining the purpose, definitions, how notifications are guided. The regulations define procedures on public comment, rulemaking, appointment of regulatory advisory panel and negotiated rulemaking panel, how meetings are conducted, public hearings on regulations and periodic review of regulations.

Decision

That analysis is published with 1 VAC 45-5 in Virginia Regulatory Town Hall.

This regulation outlines Virginia Regulatory Town Hall as the mechanism for notification, registration and meeting procedures for public participation. VSP determined there was no effect to the economic impact of small businesses, this regulation promotes public involvement in the development, amendment or repeal of the regulations of the Department of State Police
