Impact on Local Partners

Changes to the regulations promulgated by the Boxing, Martial Arts, and Professional Wrestling Advisory Board may result in less stringent requirements for promoters. If a promoter is not required to have a bond to cover the fighter's purse and gate fees, the promoter could refuse to pay the fighter or the state.

Impacts on Families

Changes to the Boxing, Martial Arts, and Professional Wrestling Advisory Board regulations may impact families not requiring fighters to provide current physicals, lab results, and eye exams. This could result in fighters who test positive for HIV or hepatitis competing and passing the condition to the other fighter.

Impacts on Small Businesses

Almost all boxers, martial artists, wrestlers, promoters, managers, and trainers are small business. Changes to the regulations promulgated by the Boxing, Martial Arts, and Professional Wrestling Advisory Board may result in less stringent safety requirements for the boxing, martial arts, and wrestling events, equating to unsafe events, including no health insurance required for the fighters. If a fighter is injured, he would be required to pay for any hospital visits. If a promoter is not required to have a barrier to separate the audience from the officials and fighters, a brawl could occur.

By having regulations, the Boxing, Martial Arts, and Professional Wrestling Advisory Board can ensure the state has safe events, by keeping the audience, the fighters, and the officials safe.
