This regulation provides the rules and regulations for the control and eradication of pullorum disease and fowl typhoid in Virginia's poultry. The incursion of these two diseases would have not only a major economic impact on Virginia's poultry industry, but a major impact on public health because contaminated food can be a source of infection for man. The regulation establishes the reporting of the disease in flocks, testing of poultry, quarantine of infected flocks, and the controls applied to flocks that are sources of hatching eggs within the Commonwealth of Virginia.

Sections 3.1-724, 3.1-726, 3.1-727 through 3.1-730 of the Code of Virginia (1950), as amended, requires the State Board of Agriculture and Consumer Services, the State Veterinarian, and all other veterinarians within the Commonwealth to use their best efforts to protect the domestic animals and poultry from disease. Consequently, the State Board of Agriculture and Consumer Services and the State Veterinarian shall establish rules and regulations to establish livestock and poultry disease surveillance, control, and eradication programs to prevent the possible spread of diseases. Furthermore the duties of the State Veterinarian, including the authority to quarantine animals and possibly persons, in cases of animal disease are specified in these sections.

- 3. The eradication of these diseases, should they occur, in Virginia.

The effectiveness of the regulation in achieving these goals is reflected, in part, in Virginia's ability to maintain Virginia's U.S. Pullorum-Typhoid Clean status allowing unconditional participation in interstate and international markets. The Commonwealth has prevented the incursion of pullorum disease and fowl typhoid because of the effectiveness of the regulation.
