# Legal basis

Please identify the state and/or federal legal authority for the regulation, including (1) the most relevant law and/or regulation, and (2) promulgating entity, i.e., agency, board, or person.

The Department of Mines, Minerals and Energy (DMME) has authority to promulgate this regulation under authority found in § 45.1-161.3, Powers of the Department, §45.1-161.254, Regulations governing conditions and practices at surface coal mines, and §45.1-161.286, Minimum blasting practices.

- Section 45.1-161.3 empowers DMME, with the approval of the Director, to promulgate regulations necessary or incidental to the performance of duties or execution of powers under Title 45.1 of the Code of Virginia.
- Section 45.1-161.254 of the Code of Virginia allows the Chief to have authority, after consultation with the Virginia Coal Mine Safety Board and in accordance with the provisions of the Administrative Process Act (§ 2.2-4000 et seq.), to promulgate rules and regulations necessary to ensure safe and healthy working conditions in surface coal mines.
- Section 45.1-161.286 of the Code of Virginia requires that when explosives are in use on the surface and an electrical storm approaches, all persons shall be removed from such blast area until the storm has passed

#### Alternatives

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. The Department considered the alternative of repealing the regulation, but determined that the regulation is still needed to protect public safety, health, and welfare. The agency also considered the alternative of amending the regulation, but determined that no amendments were necessary at this time.

DMME received no public comment in response to the Notice of Periodic Review published in *The Virginia Register*. Parties who have indicated an interest in this regulation were notified by email of the periodic review. The proposed regulation was reviewed internally by DMME. The agency did not form an advisory group to assist in the periodic review based upon perceived lack of controversy and public interest.
