Mr. Kirschner reviewed complaints received, pending, and closed for Opticians with the Board. Mr. Kirschner reported that there were three

complaints received since August, and all three are pending. No Optician cases have been closed since the last meeting. Mr. Kirschner reported that there were no complaints, received, pending, or closed for Hearing Aid Specialists.

Mr. Melis reviewed the Optician and Hearing Aid Specialist examination statistics with the Board, including a 3-year analysis of exam scoring. (See Addendum 1)

Dr. Hecker asked if applicants who were re-taking the examination could be extrapolated from the totals of examinees, and Mr. Melis agreed to look into whether or not this was possible.

Dr. Lassen arrived at the meeting at 9:48 a.m.

Old Business

Mr. Kirschner reported that there are three regulatory packages Regulations moving through the regulatory process: Fee adjustments for both Hearing Aid Specialists and Opticians; and amended regulations for Hearing Aid Specialists.

Mr. Kirschner indicated that he and Mr. Melis are scheduled to meet with the Department of Planning and Budget regarding the regulatory packages in the week following the Board meeting.

Mr. Kirschner reported to the Board on the meeting of the Ad Hoc Committee on Optician Apprenticeships that held its first meeting on October 9, 2014. Present at the meeting were board members, Mr. Flippin, Ms. Canty, Ms. Mayhew, Ms. Bauer-Robertson, and Mr. Bright, Also present were Beverly Donati from the Department of Labor and Industry, and Kristi Green, President of the Opticians Association of Virginia. Mr. Kirschner indicated that the committee had identified areas that required attention, including the length of the apprenticeship program; the awarding of credit; out of date texts and practical tasks; and deficient lab time. The committee is reviewing ways to reduce the apprenticeship hours from 6000 to 4000, and is also reviewing the Standards of Apprenticeship tasks and work processes.

Ad Hoc Committee on Optician **Apprenticeships** Report

Ms. Priola suggested that ADA information should be included in optician and/or hearing aid specialist training if it is not already a part of the instruction.

Mr. DeGennaro volunteered to become a member of the Committee.

and Mr. Kirschner noted that he will be added to the committee roster.

Mr. Flippin provided an overview of the NCSORB Annual Meeting, which he attended in Nashville, Tennessee on September 6, 2014.

NCSORB Annual Meeting Report

Mr. Melis reported on the progress of NCSORB examination contract with DPOR. The latest contract was submitted to NCSORB on 10/22/2014. The Department is awaiting NCSORB's response.

NCSORB Contract Update

Mr. Bright raised a question as to why a contract with NCSORB is required for the practical examination, but there is no existing contract with the ABO/NCLE for the written examination. Mr. DeBoer stated that a contract with the ABO/NCLE would likely be in the best interest of the Department.

Mr. Melis reported that an audit of licensing records from June 20, 2014 through August 20, 2014 was conducted. The Board received Report public comments on behalf of the Opticians Association of Virginia on the subject of the board issuing licenses when the person may not have completed their training program. In response, the Board conducted a review of both procedures and files. All files for Opticians licensed during the timeframe of June 2014 to August 2014 were audited, a total of 44. Staff discovered only one (1) instance of a candidate receiving a license prior to confirming completion of their training program (license issued July 17, estimated completion date of July 28). The Board has addressed the procedural vulnerability that enabled this, and applicants will no longer be able to register with the Department to take the exam until they have completed training.

Mr. Melis reported that the ABO/NCLE written examination is now being offered four times per year.

ABO Test Dates Update

Other Board Business

Mr. Melis reported that, knowing that allowing only completed Additional Optician applicants to test could cause delays to individuals obtaining licensure Practical Exams (such as a May graduate who would be unable to test until December), and with the ABO exam now being offered four times a year instead of just two, he sought a temporary work-around/solution (having more of the current practical examinations available) until such time as the NCSORB exam is implemented.

Mr. Melis indicated that this effort is a realistic approach to ensuring individuals are able to test and thus apply and obtain licensure in a Board for Hearing Aid Specialists and Opticians Draft Minutes of Meeting December 10, 2014 Page 6 of 7

reasonable timeframe. He stated that it was realistic, because, between contract negotiations and implementation, the NCSORB exam will take additional time, and a proactive solution was necessary in the meantime.

The Board discussed the option of increasing the number of Optician practical examination dates to four times per year. Mr. Bright reported that J. Sargeant Reynolds will soon begin charging for use of the examination site. Mr. Flippin suggested that the Board consider adding two additional practical exam dates, bringing the annual total to four, but asked that the four exams per year schedule be re-evaluated after one year. Mr. Bright asked when the new schedule could begin, and Mr. Melis responded that he believed the first practical exam under the new schedule could be administered in March 2015.

Upon a motion by Mr. Hecker and seconded by Ms. Bauer-Robertson, the Board voted to increase the number of practical examinations administered yearly from two to four with a review to be conducted at the end of 2015.

The members voting 'yes' were Ms. Bauer-Robertson, Mr. Bright, Ms. Canty, Mr. DeGennero, Mr. Flippin, Mr. Grohler, Dr. Hecker, Dr. Lassen, Ms. Mayhew, Ms. Priola, and Mr. Wagner. There were no negative votes. The motion passed unanimously.

Ms. Mayhew asked if independent optical establishments can be Independent Optical required to obtain a business license. Mr. Melis responded that current Establishments statute does not allow the Board to impose this requirement; that a statute change would be required which must be a legislative action of the General Assembly. A discussion around the issue ensued.

Mr. Melis reviewed the Election Policy approved by the Board at its **Elections** August 19, 2014 meeting, after which the Board was invited to submit nominations for Chair and Vice-Chair.

Mr. Flippin nominated Dr. Hecker for Chair; Dr. Hecker accepted the nomination.

Ms. Mayhew nominated Mr. Bright for Vice Chair; Mr. Bright declined the nomination.

Mr. Bright nominated Ms. Bauer-Robertson for Vice Chair; Ms. Bauer Robertson accepted the nomination.

Upon a motion by Ms. Canty and seconded by Ms. Mayhew, the

Board voted to close the nominations.
