CALL TO ORDER: A Special Conference Committee of the Board of Physical Therapy was called to order at 3:00 p.m.

because their presence in the closed meeting was deemed necessary and would aid the Committee in its discussions. The Committee entered into closed session at 3:05 p.m.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session at 3:15 p.m.

DECISION:



Mr. Gibbs shall inform his current physical therapy employer and each future physical therapy employer that the Board has placed him on probation and shall provide each employer with a complete copy of his Order. Mr. Gibbs must complete 8 hours of Continuing Education in addition to the required hours for renewal. Mr. Gibbs is also subject to other Terms and Conditions as outlined in the final Board Order. The motion carried.

The vote was unanimous.


ADJOURNMENT:
