There was a difference in the way other states have their bond amounts listed as they have minimum bond amounts listed and Virginia currently has maximum bond rates listed.

Research**

The Committee conducted a line-by-line review of the boxing regulations using the Regulatory Review Matrix Flowchart in order to determine the relevance of each regulation. During the review, the Committee began with 18VAC120-41-60. Discussion about professional and amateur events was held in regards to when the start time should be for the professional bouts should be during these events. Ms. Nosbisch indicated that if there was a set start time for the professional bouts, then the Board could notify promoters of this information before events.




