Ms. Daniels seconded the motion which was unanimously approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol seconded the motion which was unanimously approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Conference. Mr. Reid, respondent, and Mr. and Mrs. Law, complainants, were present and addressed the Board.

Mr. Vander Pol moved to accept the Summary of the Informal Fact-Finding Conference as to the facts of Count 1, which cites a violation of 18 VAC 15-40-120.A of the Board's regulations. Mr. Koepf seconded the motion, which was approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved to accept the Summary of the Informal Fact-Finding Conference as to the facts of Count 2, which cites a violation of 18 VAC 15-40-190.6 of the Board's regulations. Mr. Koepf seconded the motion, which was approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved to accept the Summary of the Informal Fact-Finding Conference as to the facts of Count 3, which cites a violation of 18 VAC 15-40-190.2 of the Board's regulations. Mr. Koepf seconded the motion, which was approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved to accept the Summary of the Informal Fact-Finding Conference as to the sanction and impose a \$450 fine for the violation contained in Count 1. Mr. Koepf seconded the motion, which was approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and

Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved to accept the Summary of the Informal Fact-Finding Conference as to the sanction and impose a \$1,400 fine for the violation contained in Count 2. Mr. Koepf seconded the motion, which was approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Plamer and Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved to amend the Summary of the Informal Fact-Finding Conference as to the sanction and impose a \$500.00 fine for the violation contained in Count 3, and remove the additional sanction that Mr. Reid be placed on probation and be required to submit evidence acceptable to the Board that Reid has successfully completed twenty (20) contact hours of education pertaining to the content areas covered by the Board's Home Inspector examination within six (6) months of the effective date of the order. Mr. Hyatt seconded the motion which was approved by members: Vander Pol and Hyatt. The following members voted in opposition of the motion: Cronan, Chapman, Daniels, Koepf, Loving and Palmer. Atwood and Fincher abstained. The motion failed. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Koepf moved to amend the Summary of the Informal Fact-Finding Conference as to the sanctions and impose a \$500.00 fine and probation until Mr. Reid has successfully completed a minimum of eight (8) hours of education specifically pertaining to Exterior Insulation and Finish System (EIFS) within six months of the date of the Order or certification will be suspended. Mr. Palmer seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated

to RRP until the effective date of the regulations.

Ms. Blevins was not present, did not participate in the discussion, and did not vote on this matter.

Mr. Olson presented information to the Board on the new regulatory and licensing program for Residential Building Energy Analysts. Individuals and businesses making recommendations to improve energy consumption and efficiency will be required to obtain a license issued by the Virginia Board for Contractors. Emergency Regulations have been drafted and are currently under review by the Governor's office.

Ms. Hrynciw introduced a request from staff for the Board's interpretation of 18VAC15-60-40.B, related to the eligibility for licensure of mold inspector and remediator applicants who are certified by a national or state professional mold inspectors or mold remediators association approved by the Board.

Section 54.1-517.5.B. of the Code of Virginia and 18VAC15-60-40.B. of the Board's regulations establish three elements that are required to be present for applicants to be eligible for licensure:

1. Certification by the association
2. Membership in the association
3. Standards met for membership must have been substantially equivalent to the Board's requirements

After discussion with counsel, the Board decided by consensus that substantially equivalent membership / certification requirements of experience, education, training, and examination are required pursuant to 54.1-517.5.B in order for an applicant to qualify for a license under 18VAC15-60-40.B.

After discussion, Mr. Vander Pol moved that the Board agree that certifications awarded by a national or state professional mold inspectors or mold remediators association after meeting standards substantially equivalent to the Board's requirements for licensure are a class of membership as contemplated by Section 54.1-517.5.B of the Code of Virginia and 18VAC15-60-40.B. of the Board's regulations. Mr. Hyatt seconded the motion, which was approved

by members: Atwood, Blevins, Daniels, Fincher, Hyatt, Koepf, Palmer and Vander Pol. The following members voted in opposition of the motion: Chapman, Cronan and Loving. The motion passed by majority. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

After discussion, Mr. Vander Pol moved that association members who meet membership requirements established after July 1, 2011 that are substantially equivalent to those established by the Board's regulations have met the regulation requirement of membership in and certification by the association and therefore may qualify for a license under 18VAC15-60-40.B.

Mr. Hyatt seconded the motion, which was approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Koepf, Loving, Palmer and Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

In response to training documents provided by Mr. McGuire, the Board discussed retroactively approving mold training courses that were Board approved on and after July 1, 2011. Mr. Cronan moved that the Board ask Board staff to research the feasibility of allowing a four hour Board-approved refresher training course completed after July 1, 2011, which includes the Virginia Mold Inspector and Remediator Regulations, in addition to completion of a now Board-approved initial training course prior to July 1, 2011, to satisfy the entry requirements found at 18VAC15-60-40.A.4.

Ms. Becker seconded the motion, which was approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Holtz, Hyatt, Loving, Palmer and Vander Pol. The motion passed unanimously. Mr. Koepf had left the meeting and did not participate in the discussion or vote. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

After discussion, Ms. Becker moved that the Board adopt a staff recommendation that the Board adopt a policy stating that an unlicensed individual may work under the direct supervision of a licensed mold inspector to obtain the experience required to apply for licensure as a mold inspector. The licensed mold inspector shall be present at all times while the unlicensed individual is performing mold inspections and shall approve by signature any mold inspection reports completed by the unlicensed individual. The licensed mold inspector assumes responsibility for all mold inspections completed by the unlicensed individual. Mr. Chapman seconded the motion, which was approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Loving, Palmer and Vader Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Koepf had left the meeting and did not participate in the discussion or vote.

Staff recommended, and the Board agreed, that individuals renewing their asbestos worker licenses continue to be required to complete the asbestos worker refresher training. The current practice of requiring refresher courses to be discipline-specific is consistent with the Asbestos MAP, current asbestos regulations, and the Board's 2009 interpretation of renewing lead licenses.

After discussion, Mr. Hyatt moved that the staff's recommendation be adopted as presented. Ms. Becker seconded the motion, which was approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Loving, Palmer and Vader Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Ms. Hrynciw presented draft guidance documents that are a compilation of Board actions concerning qualifications for licensure and certification, renewal qualifications, renewal procedures and conflict of interest. Once adopted, the guidance documents will be posted on the Virginia Town Hall website in

compliance with the Virginia Administrative Process Act.

Mr. Palmer moved that the guidance documents be adopted as presented by staff. Ms. Becker seconded the motion which was approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Loving, Palmer and Vader Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved that the Board adopt the amended language of the Fast Track regulations for Home Inspectors in 18VAC15-40-30, striking the word "classroom" from the language. Ms. Becker seconded the motion, which was approved by members: Atwood, Blevins, Chapman, Cronan, Daniels, Fincher, Hyatt, Loving, Palmer and Vander Pol. The motion passed unanimously. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.


Ms. Atwood, Mr. Fincher and Mr. Koepf were not present and did not vote on the motion.
