Ms. Becker, finding a quorum of the Board present, called the meeting to order at 9:05 a.m. **Call to Order**

Ms. Henshaw advised the Board of the emergency evacuation procedures. **Emergency Evacuation Procedures**

Mr. Magruder moved to approve the agenda as presented. Ms. Baynes seconded the motion which was unanimously approved by: Baynes, France, Haltigan, Koepf, Magruder, Marston, Nixon, and Palmer. Board members Becker, Holtz, and Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations. **Approval of Agenda**

Mr. Marston moved to approve the minutes of the May 17, 2016, Board meeting, and the July 27, 2016, Home Inspector Licensing Implementation Committee Meeting. Mr. Magruder seconded the **Approval of Minutes**

motion which was unanimously approved by: Baynes, France, Haltigan, Koepf, Magruder, Marston, Nixon, and Palmer. Board members Becker, Holtz, and Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

Ms. Henshaw introduced Board Member Joe T. France, who will serve as the analytical laboratory representative.

Introduction of New Board Member

Ms. Henshaw opened the floor for public comment. There were no members of the public present to address the Board regarding matters unrelated to application or disciplinary files.

Public Comment Period

In the matter of **File Number 2016-02335, Pacific Technologies, Inc.**, the Board members reviewed the application file, which consisted of the exhibits, transcript, and the Presiding Officer's summary and recommendation.

File Number 2016-02335, Pacific Technologies, Inc.

Mr. Joel Lytle, President of Pacific Technologies, Inc. addressed the Board. Mr. Lytle accepted full responsibility for the matter and asked that the Board approve the asbestos contractor license application for Pacific Technologies, Inc.

Mr. Magruder moved to accept the summary and recommendation of the Presiding Officer and approve Pacific Technologies, Inc.'s application for an asbestos contractor license. Mr. Nixon seconded the motion which was unanimously approved by: Baynes, France, Haltigan, Koepf, Magruder, Marston, Nixon, and Palmer. Board members Becker, Holtz, and Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

Mr. Nixon, Mr. Nash, and Mr. Haltigan recused themselves from the meeting for the discussions and deliberations regarding File Numbers 2016-00980, 2016-00983, and 2016-00984. Mr. Palmer advised the Board that he knew the respondent in the three files, but stated he would not recuse himself as the nature of his relationship with the respondent would not prevent him from making a fair, objective, and impartial decision in the matter.

Recusal of Board Members

Prior to presenting File Number 2016-00980, Ms. Henshaw presented the Board with a written request from the respondent's counsel for the Board to continue the review of File Numbers 2016-

Mr. Magruder seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

In the matter of **File Number 2016-00980, Melissa Sue Hart**, the Board members reviewed the record which consisted of the Report of Findings, transcript and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. After discussion, Mr. Palmer moved to accept the Presiding Officer's recommendation for Count 1, and find Ms. Hart in violation of Board Regulation 18 VAC 15-20-430.A. Mr. Magruder seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations. Mr. Magruder then moved to accept the recommendation of the Presiding officer and impose a monetary penalty of \$125.00 for Count 1. Mr. Palmer seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

After discussion, Mr. Magruder moved to accept the Presiding Officer's recommendation for Count 2, and find Ms. Hart in violation of Board Regulation 18 VAC 15-20-410.A. Mr. Palmer seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations. Mr. Magruder then moved to accept the recommendation of the Presiding officer and impose a monetary penalty of \$125.00 and license revocation for Count 2. Mr. Palmer seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because,

by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

In the matter of **File Number 2016-00983, Melissa Sue Hart**, the Board members reviewed the record which consisted of the Report of Findings, transcript and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. Mr. Palmer moved to accept the Presiding Officer's recommendation for Counts 1 and 2, and find Ms. Hart in violation of Board Regulation 18 VAC 15-20-430.A and Board Regulation 10 VAC 15-20-410.A, respectively. Mr. Koepf seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations. Mr. Palmer then moved to accept the recommendation of the Presiding officer and impose a monetary penalty of \$125.00 for Count 1, and a monetary penalty of \$125.00 and license revocation for Count 2. Mr. Magruder seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

In the matter of **File Number 2016-00984, Melissa Sue Hart**, the Board members reviewed the record which consisted of the Report of Findings, transcript and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. Mr. Magruder moved to accept the Presiding Officer's recommendation for Counts 1 and 2, and find Ms. Hart in violation of Board Regulation 18 VAC 15-20-430.A and Board Regulation 10 VAC 15-20-410.A, respectively. Mr. Koepf seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, and Palmer. Board members Becker and Holtz were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations. Mr. Magruder then moved to accept the recommendation of the Presiding officer and impose a monetary penalty of \$125.00 for Count 1, and a monetary penalty of \$125.00 and license revocation for Count 2. Recusal of Board Members

In the matter of **File Number 2016-00561, Environmental Trust Solutions, Inc.**, the Board members reviewed the record which consisted of the Report of Findings, transcript and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. Mr. Nixon moved to accept the Presiding Officer's recommendation and find Environmental Trust, Inc. in violation of Board Regulation 18 VAC 15-20-410. Mr. Palmer seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, Nixon, and Palmer. Board members Becker, Holtz, and Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations. Mr. Nixon then moved to accept the recommendation of the Presiding officer and impose a monetary penalty of \$500.00. Mr. Palmer seconded the motion which was unanimously approved by: Baynes, France, Koepf, Magruder, Marston, Nixon, and Palmer. Board members Becker, Holtz, and Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

In addition Mr. Hinz agrees to the voluntary surrender of his home inspector certificate. Mr. Marston moved to accept the terms of the Consent Order as presented. Board members Becker, Holtz, and Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to renovation, repair, and painting (RRP) until the effective date of the regulations.

Mr. Koepf returned to the meeting.

Return of Board Member

Ms. Henshaw provided an update on the current status of the regulatory review processes for the Board's regulatory packages.

Update on Regulatory Review Processes

The proposed Certified Home Inspector Regulations filed for executive branch review on November 20, 2015 have been withdrawn. This action has been replaced by the statutory licensing requirements for home inspectors to become effective July 1, 2017.

The proposed Lead-Based Paint Renovation, Repair, and Painting Program Regulations (Initial Promulgation) are currently undergoing review by the Governor's office. If approved, the regulations will be posted to the Virginia Register and a 60-day public comment period will commence, to include a public hearing.

Ms. Henshaw advised the Board that draft regulatory amendments creating home inspector licensure requirements are being developed by the Home Inspector Licensing Implementation Committee to be presented to the Board for approval. Ms. Henshaw advised the Board that subjects being discussed by the Committee include:

Report from Home Inspector Licensing Implementation Committee

- Experience requirements;
- Conviction disclosure;
- Condensing the renewal/reinstatement process; and
- Insurance

Ms. Henshaw advised the Board of an amendment to the Administrative Process Act granting the right to counsel in rule-making proceedings, requiring an amendment to the language in Board Regulation 18VAC160-11-50. Ms. Henshaw advised that because this is a statutory change, the amendment may be made through the fast-track process. Mr. Magruder moved to authorize staff to move forward with the fast-track process in order to make the necessary amendment to the regulation. Mr. Nixon seconded the motion which was unanimously approved by: Baynes, France, Haltigan, Koepf, Magruder, Marston, Nixon, and Palmer. Board

Ms. Henshaw provided an update of the asbestos course audits that have been conducted since the Board's last meeting. Ms. Henshaw advised that due to the absence of a Board Administrator, non-mandatory audits are currently not being completed. Ms. Henshaw advised that the agency is currently recruiting to fill the Board Administrator position, and audits will proceed when the position is filled.

Ms. Henshaw advised the Board that the Department of Labor and Industry (DOLI) requested clarity on requirements for demolitions of structures in which asbestos containing caulking is present. DOLI currently requires a licensed asbestos supervisor to be onsite at such demolitions, but it is not clear whether a licensed asbestos abatement contractor is required to remove the caulking when the caulking is non-friable. After lengthy discussion, the Board agreed by consensus that all asbestos containing material, including non-friable material, must be removed before structure demolition by a licensed asbestos abatement contractor, with the exception of roofing, flooring, and siding materials that are non-friable and will not become friable.
