the Notice with Mr. Barrett.

meeting pursuant to § 2.2-3711(A)(27) of the Code for the purpose of deliberation to reach a decision in the matter regarding **Ross S. Barrett, SLP**. Additionally, Ms. Burge moved that Ms. Knachel and Ms. Moss attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations. The motion was

seconded and carried unanimously.
