DECISION:

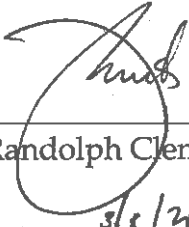
Upon a motion by Dr. Walker, and duly seconded by Dr. Conklin, the Committee voted to dismiss the matter.

DECISION:

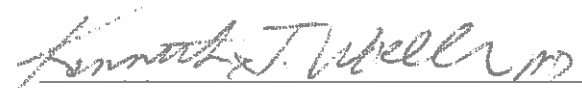
Upon a motion by Dr. Clements, and duly seconded by Dr. Conklin, the Committee voted to dismiss the matter.

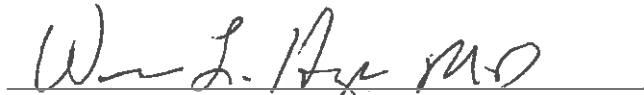

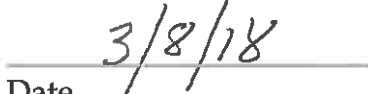
