mail. The Chair opined proper notice of the proceeding had been provided to Mr. Blair and the formal hearing proceeded in Mr. Blair's absence. The Board received sworn testimony from witnesses called by the Commonwealth.

CLOSED SESSION:

Upon a motion by Dr. Koziol, and duly seconded by Ms. Carlson, the Board voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Mr. Blair. Additionally, he moved that Ms. Barrett, Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Board in its deliberations.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Board re-convened in open session and announced its decision.

DECISION:

Upon a motion by Ms. Hickey, and duly seconded by Dr. Walker, the Board made certain findings of fact and conclusions of law and voted to deny reinstatement of Mr. Blair's license and to revoke his license.

VOTE:

The vote was unanimous.

The Board adjourned at 2:56 p.m.
