FINAL ORDER

Before the Court is the Petition for Appeal filed by petitioner Walter H. McCrory, Jr., pursuant to Rule 2(A):2 of the Rules of the Bupreme Court of Virginia and Section 2.2-4003, et. seq. of the Virginia Administrative Process Act of the Code of Virginia; and Petition being an appeal from the June 14, 2010 Final Opinion and Order of respondent Virginia Board for Branch Plicia. The Court has carefully reviewed the Petition for Appeal, the Brief in Support of Petition for Appeal, Brief in Opposition to Petition for Appeal, the Raply Brief and the Record from the proceedings below (Including the transcript of the hearing of April 29, 2010), and has heard the arguments of coursel. The Court holds that the Board's determination denying Petitornar's Application for Licensum as a Branch Pilot is not supported by substantial evidence and that a reasonable mind reviewing the evidence presented would necessarily have come to a different conclusion than the Board did; and this Court therefore REVERSES and VACATES the Board's First Opinion and Order of June 14, 2010, and REMANDS this matter to the Board for further proceedings consistent with this Court's determinations.

In further support of its nating, the Court adapts and incorporates its findings stated at the hearing on May 6, 2011, and the Court reserves the state to insue a further written cointon.
