This rulemaking is to reissue the general permit that expires on June 30, 2004. It will continue the existence of the general permit that establishes limitations and monitoring requirements for point source discharges from nonmetallic mineral mining facilities. As with an individual VPDES permit, the effluent limits in the general permit are set to protect the quality of the waters receiving the discharges. Only minor changes were made to the existing regulation in order to update it.

The State Water Control Board adopted 9 VAC 25-190 as amended at their meeting of March 23, 2004.

#### SUMMARY OF PUBLIC COMMENTS AND AGENCY RESPONSES: REISSUANCE AMENDMENT TO GENERAL VPDES PERMIT REGULATION FOR NONMETALLIC MINERAL MINING 9 VAC 25-190-10 et seq.

#### February 3, 2004

Following is a compilation of oral and written comments received during the public notice period for this draft regulation. The public notice period began December 1, 2003 and ended on January 30, 2004 and a public hearing was held in Richmond, Virginia on January 13, 2004 with Leroy O. Pfeiffer, Sr., State Water Control Board, serving as hearing officer.

No one attended the hearing for this reissuance. One comment was received through electronic correspondence. It and the review response from the U.S. Environmental Protection Agency are summarized below.

#### Summary of comments and agency responses:

**1. Comment:** The 30 mg/l <u>average</u> limit for Total Suspended Solids in the permit should be a 30 mg/l <u>minimum</u> limit.

**Response:** The commenter apparently misunderstood the meaning of this limit and it was explained that the 30 mg/l limit for Total Suspended Solids is a monthly average not to be exceeded, not the minimum number that all facilities must attain.

**2. Comment:** EPA approves the draft reissuance of the general permit.

**Response:** No response necessary.
