The purpose of this regulatory action is to consider expanding the Eastern Virginia Ground Water Management Area to include the remaining portion of Virginia's coastal plain.

Ground water levels in the undesignated portion of Virginia's coastal plain are continuing to decline. Impacts from ground water withdrawals are propagating along the fall line into the undesignated portion of Virginia's coastal plain and have the potential to interfere with wells in these areas without assigned mitigation responsibilities. Given current ground water declines, the entire coastal plain aquifer system must be managed to maintain a sustainable future supply of ground water.

#### Substance

Section 9VAC25-600-20 will be amended to include the following additional counties and one city: Caroline, King and Queen, Gloucester, Mathews, Middlesex, Essex, Spotsylvania (part), Stafford (part), Prince William (part), King George, Westmoreland, Richmond, Lancaster, Northumberland, Fairfax (part), Arlington (part); and Alexandria City.

#### Alternatives

Alternatives to designation are limited as this is currently the only means authorized to manage ground water withdrawals and their impact on other users and water levels in the coastal plain aquifer system. However, the Department will solicit public input and consider other alternatives and issues presented by the public which also meet the goals of the regulation and of the agency.
