	20		Regulation references the Groundwater Act of 1973	The Groundwater Act of 1973 has been repealed and replaced with the Ground Water Management Act of 1992. The citation referencing the Ground Water Management Act of 1992 has also been updated.

The amendments are corrections of technical errors and are being made using the exempt final process as allowed by § 2.2-4006 A 3 of the Administrative Process Act.
