The Board for Asbestos, Lead, and Home Inspectors adopted proposed amendments to the training program notification and participant list requirements of the Lead-Based Paint Activities Regulations on May 19, 2004. These amendments are necessitated by the implementation of the EPA Final Rule (http://www.epa.gov/opptintr/lead/notification%20final.pdf) regarding Notification Requirements for Lead-Based Paint Abatement Activities and Training, effective May 10, 2004.

The regulations currently require training providers to notify the department no less than 48 hours prior to conducting an accredited lead training program, and require training providers to provide to the board the training program participant list within 24 hours of the training program completion.

Amendments to section 18 VAC 15-30-420 specify that notifications must be submitted by the training manager. The notification submission period has been expanded from 48 hours to

seven business days prior to the training course. Specific timeframes have been established for any change in start date, training location, or cancellation of the training program. The amendments list specific information that each notification must include.

The amendments specify that participant lists must also be submitted by the training manager. The participant list submission period has been expanded from 24 hours to ten business days following the training program completion. The amendments list specific information that each participant list must include.

Also, the method of submitting notifications and participant lists, currently used as department procedure, is established in regulation.

Language has been modified in section 18 VAC 15-30-820 to indicate that failure to submit notifications and participant lists as required and in the manner described in section 18 VAC 15-30-420 is a violation of the Board's regulations.

The Board is seeking to promulgate these amendments via the Exempt procedures as provided for in § 2.2-4006.A.4.c of the Administrative Process Act, which are necessary to meet the requirements of federal regulation. The Board's Lead-Based Paint Activities Regulations must be as restrictive as EPA's regulations for Virginia to maintain its status as an EPA-Authorized State; and the Code of Virginia requires Virginia's regulations to be no more stringent than EPA regulations (§ 54.1-501.6).
