The Virginia Board for Asbestos, Lead, and Home Inspectors has adopted a temporary reduction in the renewal and reinstatement fees for home inspector licenses and home inspector with NRS specialty licenses. Fee reductions will remain effective until February 2024.

In addition, this action also corrects for technical errors in the regulation.

Mandate and Impetus

Section 54.1-113 of the Code of Virginia ("the Callahan Act") states, in part:

A. Following the close of any biennium, when the account for any regulatory board within the Department of Professional and Occupational Regulation or the Department of Health Professions maintained under § 54.1-308 or 54.1-2505 shows expenses allocated to it for the past biennium to be more than 10 percent greater or less than moneys collected on behalf of the board, it shall revise the fees levied by it for certification, licensure, registration, or permit and renewal thereof so that the fees are sufficient but not excessive to cover expenses.

At the close of each biennium, the Department of Professional and Occupational Regulation is required to review each board's financial position to determine whether fees need to be adjusted to ensure that revenues are sufficient, but not excessive, to cover the board's operating expenses. This regulatory change was prompted by a Department review of the Board's current financial position, and projected revenues and expenses for the current (2020-2022) and next (2022-2024) biennia. The purpose of the fee reductions is to reduce an accumulated budget surplus and remain in compliance with the Callahan Act.

This regulatory action is exempt from the Administrative Process Act pursuant to §§ 2.2-4006(A)(3) and 2.2-4006(A)(6) of the Code of Virginia.
