The regulation is being modified in response to Chapter 139 of the 2014 Acts of Assembly. As of July 1, 2014, a permit will not be required to transport hazardous waste, and modifications are being made to the regulation to remove this requirement. Transporters of hazardous waste will continue to comply with federal and state regulations that address the transportation of hazardous waste. A hazardous waste transporter will continue to be required to have an EPA identification number before it may transport hazardous waste.

The Virginia Waste Management Board adopted final amendments to the Virginia Hazardous Waste Management Regulations on June 24, 2014.

Regulatory flexibility analysis

Alternative regulatory methods include, at a minimum: 1) the establishment of less stringent compliance or reporting requirements; 2) the establishment of less stringent schedules or deadlines for compliance or reporting requirements; 3) the consolidation or simplification of compliance or reporting requirements; 4) the establishment of performance standards for small businesses to replace design or operational standards required in the proposed regulation; and 5) the exemption of small businesses from all or any part of the requirements contained in the proposed regulation.

This regulatory amendment removes the requirement for hazardous waste transporters to obtain a hazardous waste transporter permit from the state of Virginia. This decreases the amount of paperwork a transporter of hazardous waste is required to obtain to transport hazardous waste. Hazardous waste transporters must continue to obtain an EPA identification number from the EPA or an authorized state prior to transporting hazardous waste. Transporters must also continue to use manifests to track the transportation and transfer of hazardous waste. Since there are federal regulations that address the transportation of hazardous waste that must be adhered to, there are no alternative regulatory methods that the Board may use to further reduce the regulatory burden on hazardous waste transporters, including those that are small businesses.
